RE: *Complaint and Request for Investigation of Gould for Congress (C00506253)*

Dear Mr. Herman:

I am writing to you today to ask that you investigate Mr. Ron Gould, Ms. Janice Gould in her role as treasurer, and Gould for Congress (C00506253) (Gould for Congress or Ron Gould) for the possible violations of the of the Federal Elections Campaign Act (FECA). Specifically, public records show that Ron Gould or Gould for Congress: 1) used prohibited non-federal funds to pay for campaign consulting services that benefited his federal race in violation of federal campaign finance laws and 2) Gould for Congress improperly reported and failed to disclose contributions as required under the federal campaign finance laws.

1) Gould for Congress used prohibited money to fund Ron Gould's federal campaign

The first concern is that it appears that Ron Gould used prohibited money in his federal campaign. Federal law, 2 U.S.C. 441i(e)(1)(A) states: "No person described in 11 CFR 300.60 shall solicit, receive, direct, transfer, spend, or disburse funds in connection with an election for Federal office, including funds for any Federal election activity as defined in 11 CFR 100.24, unless the amounts consist of Federal funds that are subject to the limitations, prohibitions, and reporting requirements of the Act." In short, this provision requires that only money raised in a federal election can be used for the federal race, and a candidate cannot use money from other sources.

Records show that, on November 3, 2011, State Senator Ron Gould paid Bluepoint Consulting LLC (Bluepoint) \$14,000 for "Professional Service - Consultants" from his State of Arizona campaign finance committee "Committee to elect Ron Gould" #200693272

(State Committee). This payment was given to Bluepoint consulting despite the fact that Mr. Gould was term limited and he was prohibited from running again for an additional term as state senator. In short, there was no legitimate state election purpose for these professional services.

Shortly after paying Bluepoint Consulting, LLC, on November 15, 2011, a Statement of Organization was created for Ron Gould for Congress for his Exploratory Campaign to avoid Arizona's resign to run law, which would have required Mr. Gould to resign his state senate seat had he filed a full committee prior to January 1, 2012. On December 30, 2011, Mr. Gould's campaign paid Bluepoint an additional \$2,500 for "Professional Service - Consultants" from his *State Committee*. And on January 11, 2012, Mr. Gould amended his Statement of Organization.

In 2011, Ron Gould paid Bluepoint \$17,500 for "Professional Service - Consultants" from his state election account despite the fact he was term limited and had already announced his intent to run for Congress. It is doubtful there was any "consulting" necessary, much less the enormous sum of \$17,500, for a state campaign that was essentially closed. The record does establish that a federal election campaign was in progress, however, and use of the state funds was an effort to circumvent and evade federal election laws.

Since those payments in 2011, Bluepoint and its sole owner, Chris Baker, have been working for - and on behalf - of the Ron Gould for Congress campaign as evidenced by the following: On January 05, 2012, the Arizona Republic reported: "State Sen. Ron Gould plans to announce his candidacy in the next week or so, campaign adviser Chris Baker said." On April 06, 2012, the Arizona Republic reported: "Chris Baker, campaign consultant for State Sen. Ron Gould, said the ad will not persuade voters to support the sheriff." On April 24, 2012, the Arizona Republic reported: "Campaign consultant Chris Baker said Gould sees Babeu as 'irrelevant . . . He can run ads until the cows come home, talking about what a conservative he is,' Baker said. 'But the voters know too much about Paul Babeu by now.'" On May 4, 2012 the Arizona Republic refers to Chris Baker as Gould's Campaign Consultant and longtime consultant for the Club for Growth.

However, neither Bluepoint nor Chris Baker are listed as expenditures on either Mr. Gould's 1st or 2nd Quarter Federal Election Commission reports for any "consulting" or related services. The only payment made to Bluepoint was to reimburse a vendor, Jamestown Associates for invoice #9368.

By contrast, Bluepoint averages about \$4,000 a month for similar FEC committees and has received over \$700,000 from the Club for Growth, who is extravagantly backing Mr. Gould, with close to \$200,000 spent to date for Ron Gould. In short: according to Ron Gould, he has not paid his campaign consultant one nickel under his federal campaign account, even though Chris Baker has been his consultant since at least November 2011. What is also

clear is that Ron Gould paid Chris Baker with money from his state account for his federal Congressional campaign. Such a transaction violates federal law, violates transparency, and is intended to mislead voters and the general public.

It should also be noted that Bluepoint, and its owner Mr. Chris Baker, have a long-standing relationship and have been investigated in the past for violating Arizona campaign finance violations. In 2004, Gould settled a complaint by the Arizona Clean Elections Commission for failure to report more than \$12,000 in campaign expenditures.

2) Gould for Congress failed to properly report its "bundled" contributions on Form 3L as required. Additionally, Gould for Congress failed to disclose certain individuals who were reported as "bundled" contributions from the Club for Growth.

Federal law, the 'Honest Leadership and Open Government Act of 2007' (HLOGA) provides:

11 CFR 104.22(b)(1)—FEC Form 3L HLOGA Section 204 requires reporting committees to disclose certain information about each person reasonably known by the reporting committee to be a lobbyist/registrant or lobbyist/registrant PAC that "provided 2 or more bundled contributions" aggregating in excess of the reporting threshold to the reporting committee during the covered period. See 2 U.S.C. 434(i)(1).

The Gould for Congress campaign, and its treasurer, failed to 1) properly file bundling disclosure reports on FEC Form 3L, 2) disclose the date of transfers from Club for Growth, and 3) disclose the amount of bundled contributions from the Club for Growth. Form 3L requires candidate committee's to put the contributor's information and immediately after that entry, as a memo entry, and put the bundler's information. Gould's amended July report does no such thing. Without that information, it is impossible for the average person to determine the source of Mr. Gould's donations.

According to the Club for Growth's June report, there were over 150 earmarked contributions listed for Mr. Gould. However, Gould's July report makes no mentions which of those contributions are from the Club for Growth in excess of \$50,000. (See: <http://query.nictusa.com/pdf/837/12952576837/12952576837.pdf#navpanes=0>) Also see FEC Form 3L, enclosed.

It also appears that the Gould for Congress campaign, and its treasurer, did not disclose all its contributions. A perfunctory review shows that at least the following contributions were not reported on the June report: Mr. Robert Bartels, \$750 on June 14, 2012, Mr. Bartel's is not included on Mr. Gould's report. Additionally, missing contributions include: Mr. Robert Battle, \$500 on June 4; Mr. Ed Ligon, \$505 on June 4; Mr. John Popp, \$250 on June 13; and

Saul Rosenzweig, \$1,000 on June 7, 2012. Finally, it is unclear whether Mr. Gould's campaign properly attributed contributions for the primary and the general election.

Accordingly, the Gould for Congress campaign committee has not properly filed its campaign finance report, as required, and has activity that raises suspicion into the accuracy of the report. Due to the number of missing reported, and the improper filing of contributions, an inference that the campaign is attempting to shield the source of its donors or mislead the public can be drawn or has a complete disregard for the law all together.

Given Mr. Gould's past transgressions in regards to campaign finance laws and the evidence included in this document, I respectfully request you investigate the Mr. Ron Gould, Mrs. Janice Gould, and the Gould for Congress campaign committee for possible violations of the Federal Elections Campaign Act as amended.

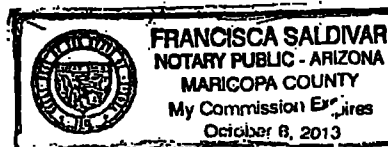

SETTLEMENT AGREEMENT

Pursuant to R2-20-216, R-20-217(C) and R2-20-225 of the Arizona Administrative Code, the Citizens Clean Elections Commission (the "Commission") and Ron Gould, a participating candidate for State Senate District 3 (hereinafter, the "Respondent"), agree to enter into a public administrative settlement of the above-captioned matter in the manner described below.

1. The Commission finds that Respondent failed to timely report campaign expenditures in accordance with A.R.S. §§ 16-913 and 16-915. More specifically, the Commission finds that:

- a) On August 6, 2004, Bluepoint Consulting conducted campaign phone calls on behalf of the Committee to Elect Ron Gould.
- b) Bluepoint Consulting conducted a second set of calls on behalf of the Committee to Elect Ron Gould on August 16, 2004, and a third and final set of calls on September 1, 2004.
- c) The total cost of the on-going program was \$12,425.00, which Respondent paid on September 3, 2004.
- d) The 2004 Pre-Primary Report covered reporting of contributions and expenditures for the period between June 1, 2004 and August 18, 2004.
- e) Respondent filed his Post-Primary Campaign Finance Report on October 6, 2004,

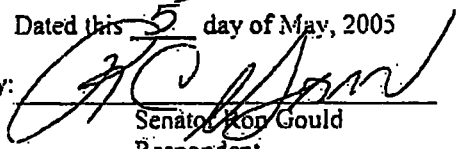
1 (33) days elapsed from the last day to file the Pre-Primary Election Campaign Finance Reports
2 to the first day to file the Post-Primary Election Campaign Finance Reports.

3 3. The Commission declines to impose the maximum penalty for the following
4 reasons:

- 5 (a) Respondent cooperated fully with the investigation and resolution of this matter;
6 (b) Absence of a prior enforcement action before the Commission;
7 (c) Respondent complied with the reporting requirements under the Citizens Clean
8 Elections Act once the violation was brought to his attention; and,
9 (d) Respondent's failure to timely report his expenditure did not result in a delay of
10 matching funds for any candidate.

12 Accordingly, the Commission agrees that all proceedings commenced by the
13 Commission shall be terminated and the matter be closed upon payment of the civil penalty.
14 This agreement is subject to final approval by the Commission during its May 11, 2005
15 meeting.

Dear Mr. Gould:

Thank you for your timely response to the Commission's Order Requiring Compliance issued February 10, 2005, and for agreeing, within the time allowed, to amend your campaign finance reports to achieve full compliance with the requirements of A.R.S. Sec. 16-948(C).

A. Payment Directly to Person Providing Goods or Services

Your response enables me to find the amendments to your campaign finance reports satisfy the requirements of A.R.S. § 16-948(C), and therefore, all expenditures of campaign funds by the Committee to Elect Ron Gould were for direct campaign purposes in compliance with Commission rules.

B. Timely Reporting of Expenditures

In your initial Response to the Complaint in this Matter, you stated that the Committee to Elect Ron Gould conducted campaign phone calls on August 6, 2004 as part of an on-going program, and that the cost of the program along with two other on-going phone banks was paid by the campaign on September 3, 2004. Your Post-Primary Report, for which the filing period began September 28, 2004, identifies an expenditure to Bluepoint Consulting of \$12,425.00 for "Phones #1 \$4,300, #2 \$5375, #3 \$2750."

Your Response dated February 28, 2005, to the Commission's Order did not address further the timely reporting of expenditures.

"Expenditures" for purposes of the Act are defined in A.R.S. Sec. 16-901(8) and include not just payments but also contracts, promises or agreements to make an expenditure resulting in an extension of credit.

The agreement with the phone bank, made through Bluepoint, must have been made prior to August 6, 2004, when calling began. After calling began on August 6, 2004, the Committee became an obligor, to pay for the costs being incurred, with the phone bank extending credit to Bluepoint and Bluepoint extending credit to the campaign. Thus, on August 6, 2004, the Committee made an expenditure which was not reported until at least September 28, 2004, but should have been reported on the Committee's Pre-Primary Report for which the filing period began August 19, 2004.

In your first Response to the Complaint you asserted that the Arizona law governing reporting expenditures is not within the jurisdiction of the Clean Elections Commission. I find that two provisions of the Act, A.R.S. Sec. 16-941(C)(2) and A.R.S. Sec. 16-956(A)(7) provide jurisdiction to the Commission in this area.

Furthermore, A.R.S. Sec. 16-942(B) provides for a civil penalty of \$110.00 per day for the violation of any reporting requirement imposed by Chapter 6 of Title 16. A period of 33 days elapsed from the latest time the expenditure for the phone bank should have been reported (August 26, 2004) to the beginning of the period it was reported September 28, 2004). As the phone calling was on-going, and the total cost of Phone Bank #1 was \$4,300, I find that a civil penalty of \$3,630 is reasonable and appropriate.

C. Recommendation to the Commission

Based on the foregoing findings and brief review of the applicable law, I will recommend (1) that the Commission make a public finding that the Complaint insofar as it alleges a violation of the Act's requirement that payments be made directly to the person providing goods or service be dismissed based upon your compliance following receipt of the Commission's Order, and (2) that the Commission make a public finding that there is probable cause to believe that the Respondent violated reporting requirements of the Act by not reporting expenditures incurred on August 6, 2004, and thereafter through August 18, 2004, on a Pre-Primary Report as required. I will recommend a civil penalty of \$3,630, for which the candidate and the candidate's campaign shall be jointly and severally responsible.

D. Briefing Procedures

Within five days from the receipt of this letter from the External Investigative Consultant, Respondent may file a brief with the Commission setting forth the Respondent's position on the factual and legal issues of the case pursuant to A.A.C. R2-20-214(C). After reviewing the respondent's brief, the External Investigative Consultant shall promptly advise the Commission in writing whether he intends to proceed with the recommendation or to withdraw the recommendation from Commission consideration. A.A.C. R2-20-214(D).
