GENERAL COUNSEL'S REPORT

I. BACKGROUND

On July 31, 1978, the Reports Analysis Division referred two non-filers to the Office of General Counsel for failure to file a Statement of Candidacy and designate a principal campaign committee. The Commission found reason to believe on June 2, 1978, and reasonable cause to believe on June 22, 1978, that a violation of 2 U.S.C. §432(e)(1) and 11 C.F.R. 101.2 had occurred.

II. ANALYSIS

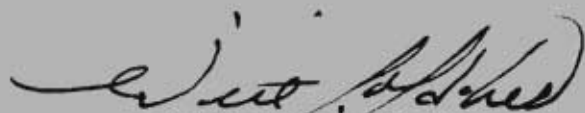
Subsequent to the referral, General Counsel staff contacted the non-filers by telephone and requested that they file the required reports. Both respondents have now filed the necessary reports with the Commission (See Attachments). Accordingly, the General Counsel recommends that the Commission take no further action and this matter be closed.
