I have been retained to represent Cal Voters for Honest Government (hereinafter also referred to as "Cal Voters or my client and incorporated by that reference). This is in response to allegations filed as MUR 6828.

All allegation contained in the attached complaint to your letter are not only unfounded but also made based on certain assumptions. As stated below, all the assumptions are false and incorrect. Therefore, the complaint must be dismissed and the complainant party must be reprimanded.

1. All activities of Cal Voters have been examined by a monitor and all necessary filings have been made properly. The cost of mailers did not exceed \$10,000, a false assumption on part of Mr. George Alfanso (complaining party).
2. All mailers have contained the required legal disclosure.

3. [www.veteranjobaca.com](http://www.veteranjobaca.com) website has nothing to do with my client (Cal Voters).
4. Cal Voters have made no contributions to Mr. Joe Baca's campaign. The Cal Voters Committee made independent expenditures in support of the candidate.

In conclusion, none of the allegations are true and based on false assumption. I respectfully request that the complaint must be dismissed with prejudice.
