OFFICE OF GENERAL COUNSEL Certified by The California Secretary of State, Debra Bowen, I was the Republican Candidate, 51st District for the November 2014 election for Representative to The 114 Congress. I was not elected by final count. Juan Vargas was {APPARANTLY} Elected.

Earlier (prior to candidate filing march 7th) this year, U.S Prosecutors named Mexican Foreign National, one Mr. Jose Azano, a "non-green- card", part-time Coronado, CA. resident and, Retired San Diego Police Officer Ernesto Encinas, for illegal election tampering. Others were also also named; among them, my opponent, Congressman Juan Vargas for having taken donations, both direct land indirectly. Taken as cash \$7000 to \$7500. Rep. Vargas admitted taking the cash but convinced authorities "he was unaware they were illegal funds" and no legal steps were taken against .Mr. Vargas; subsequently that money was refunded from his campaign chest. Among those particular donors was above noted Ernesto Encinas. Mr. Encinas has also pleaded guilty for "acting as a go between with for Mr. Azano and Mr. Vargas". Furthermore in this respect, Mr. Encinas has pleaded guilty to Federal Election offenses; and was to have been sentenced in federal court. Federal Court documents show Mr. Vargas took the money about september 2012 but did not return it until early 2014. Mr. Vargas has publicly stated he had a" close and trusting relationship "with Mr. Encinas spanning several different elections (five?) and public office terms". Good fiends. For several months, Mr Vargas did not respond to media inquires about his relations with Mr. Encinas. Finally Mr. Vargas admitted it was a "long and close affair." Mr Vargas also added that, over the years Mr. Encinas was unquestionably "Upright." Mr. Vargas added: "I am disappointed surprised Ernesto's 'character change."

Further dubious donations: a \$30,000.00 check was written by one Mark Chase of La Jolla, CA.( A dealer in luxury cars of which Mr. Azano is said to have purchased more than one to indicate a relationship exists between buyer and seller: perhaps, favors returned for being a good customer. However Federal Prosecutors contend it was "Azano money" and it went to a PAC: The Democrat Congressional Committee (DCCC) indirect contribution. When I queried the DCCC, I sought acknowledgement of this affair, or if was deemed illegal or refunded as such; The DCC did not respond.

To my knowledge. Mr. Vargas, in addition to the 2012 run, was also elected to San Diego City Council, both California Legislative Houses and also ran (2006) for Congress unsuccessfully. Current Republican Party of Imperial County California Mr. Miles Blake, was the failed November Election Republican Candidate in that run-off. Mr. Blake recently told me that he suspected "foreign money" interference as did The Democrat Winner Bob Filner. Mr. Blake contends a furious feud between Filner and Vargas developed and Filner supposed "had" something on Vargas but did not pursue.

For each of those political campaigns he took the Oath Required, as did I, on filing for the election. With all of the allegations swirling: meetings with foreign nationals (September 17, 2012 or thereabouts a dinner meeting with Mr. Azano in a downtown San Diego restaurant) and, his legal astuteness bespeak what is legal and what is not and how one should cover himself for a misstep. Being of obvious Hispanic Descent, he probably has knowledge Mexican MORDIDATA; under the table dealings. In my opinion, the foregoing warrants The Secretary of State, The San Diego County Registrar of Voters, and the Federal Election Committee to make a thorough investigation—starting from the 2012 Campaign, into as many campaigns as needed to prove Mr. Vargas INNOCENT or GUILTY of FALSE OATH. If misdeeds are discovered, Mr. Vargas OATH ON FILING FOR 2014 CANDIDACY must be declared FALSE and therefore the California Secretary of State should, retroactive to FILING DATE, revoke certification leaving Stephen Meade on the ballot as unopposed and there rightful WINNER.

As a PARALLEL EFFORT, at my expense, I will have professional investigators do the same.

Please note: the Federal Grand Jury Indictment in connection with U.S. District Court Case No. 14CR Filed 2014 AUG 12 involving U.S. District Court Case No. 14CR0388-MMA mentions just about everything in the foregoing. I personally filed a Complaint with the FEC 2 September 2014. An attorney at the FEC says no action has yet been take. I request urgency by all Federal, Stat and Local Agencies.

ANTICIPATING OVERTURNING THE ELECTION AND STEPHEN MEADE TO BE DECLARED WINNER SO AS TO BE SWORN REPRESENTATIVE AT OPENING OF THE 114TH CONGRESS. TIME IS OF THE ESSENCE.
