This office represents Mr. John Ellis "Jeb" Bush in the above-captioned MURs. Enclosed please find executed Statement of Designation of Counsel forms which are intended to supersede those previously filed to designate Raquel A. Rodriguez as counsel in these matters.

Governor Bush has received both complaints and supplements thereto – the most recent of which on June 9, 2015 – in the above-captioned MURs concerning alleged violations of the Federal Election Campaign Act of 1971, as amended. Our office was only recently retained by Governor Bush in connection with these matters and will need more than the 15-day allotted time to confer with our client, investigate the allegations in the numerous complaint and supplemental materials, and to compile a comprehensive response.

We respectfully request the traditional 30-day extension to file a response, but seek an additional 60 days – until September 22, 2015 – given the clear demands on our client's time resulting from his just-announced presidential candidacy. We understand that the practice of your office is to grant such an extension in exchange for an agreement to toll the statute of limitations which we are prepared to accept.
