III. BACKGROUND:

Other Violations of the Federal Election Campaign Act (Unauthorized Use of Committee Funds)

The McConnell Senate Committee '14 ("the Committee") filed the 2014 30 Day Post-General Report disclosing unauthorized activity totaling \$100,634.00 and partial restitution payments totaling \$32,960.00.

On November 25, 2014, Sean Cairncross, the Committee's counsel, contacted Reports Analysis Division (RAD) Management for guidance on how to properly disclose restitution payments on the 2014 30 Day Post-General Report. Mr. Cairncross stated that an outside vendor (not an employee of the Committee) misappropriated approximately \$100,000.00 in contributions made to the Committee from the Committee's mail and deposited these funds in a ghost account. The Federal Bureau of Investigation (FBI) and Department of Justice (DoJ) arrested and seized the assets of this individual. The Committee received approximately \$30,000.00 in restitution funds from the DoJ. The FBI and DoJ are working with the embezzler to recover the remaining funds. Mr. Cairncross stated that the Committee has a spreadsheet containing the information of the

contributors whose contributions were stolen by the outside vendor. RAD Management advised Mr. Cairncross to have the Committee provide a cover letter with the 2014 30 Day Post-General Report explaining the details of the embezzlement, to disclose the restitution amount on Schedule A supporting Line 15 (Other Receipts) of the Detailed Summary Page, and to attach the spreadsheet containing the contributor information. RAD Management advised Mr. Cairncross to have the Committee disclose future restitution payments on Schedule A supporting Line 15 of the Detailed Summary Page and include a cross-reference to the spreadsheet provided with the 2014 30 Day Post-General Report. After the phone call, RAD Management emailed Mr. Cairncross the Embezzlement Guidance issued by the Commission in 2011 (Attachment 4).

On December 2, 2014, Lisa Lisker, the Committee's Assistant Treasurer, called RAD Management seeking guidance on how to disclose the restitution check, received by the Committee from the U.S. Treasury, on the 2014 30 Day Post-General Report. RAD Management advised Ms. Lisker to disclose the receipt from the U.S. Treasury and to include memo text identifying the outside vendor and explain the situation. RAD Management reiterated that the Committee may file the spreadsheet containing contribution information, in lieu of amending previous reports to provide this information. Ms. Lisker provided additional details regarding the embezzlement: the outside vendor misappropriated funds of four other entities, including three federal committees and one non-profit organization. Ms. Lisker said the Committee became aware of the embezzlement because a longtime contributor to the Committee had not received a thank-you card from the Committee for a contribution. The Committee contacted the bank regarding this contribution and discovered that the contribution was deposited into the ghost account, established by the outside vendor. Ms. Lisker explained that the Committee never saw the contribution checks embezzled by the outside vendor, as the vendor regularly processed checks for the Committee that were received in a P.O. Box (Attachment 4).

On December 4, 2014, the Committee filed the 2014 30 Day Post-General Report covering the period from October 16, 2014 through November 24, 2014. The report included a spreadsheet listing contributions totaling \$100,634.00 that were taken by the outside vendor (Images 14021370373-84, Attachment 2). The report also disclosed a partial restitution of embezzled funds on Schedule A supporting Line 15 of the Detailed Summary Page totaling \$32,960.00 from U.S. Treasury for "Repayment of diverted funds-see memo" (Image 14021370797, Attachment 3). The report included memo text, which stated, in part:

"The receipt disclosed on line 15 from the US Treasury is a partial repayment of funds diverted from the Committee by an outside vendor. Please see the attached list of contributors whose contributions were reported to the Committee as having been diverted" (Image 14021370368).

To date, no further communications have been received from the Committee regarding this matter.
