
I am writing to you in response to complaint MUR6985 received by my office. Below are the reasons why no action should be taken against the New York State Conservative Party.

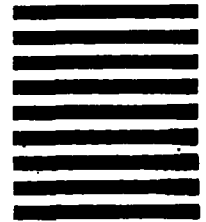

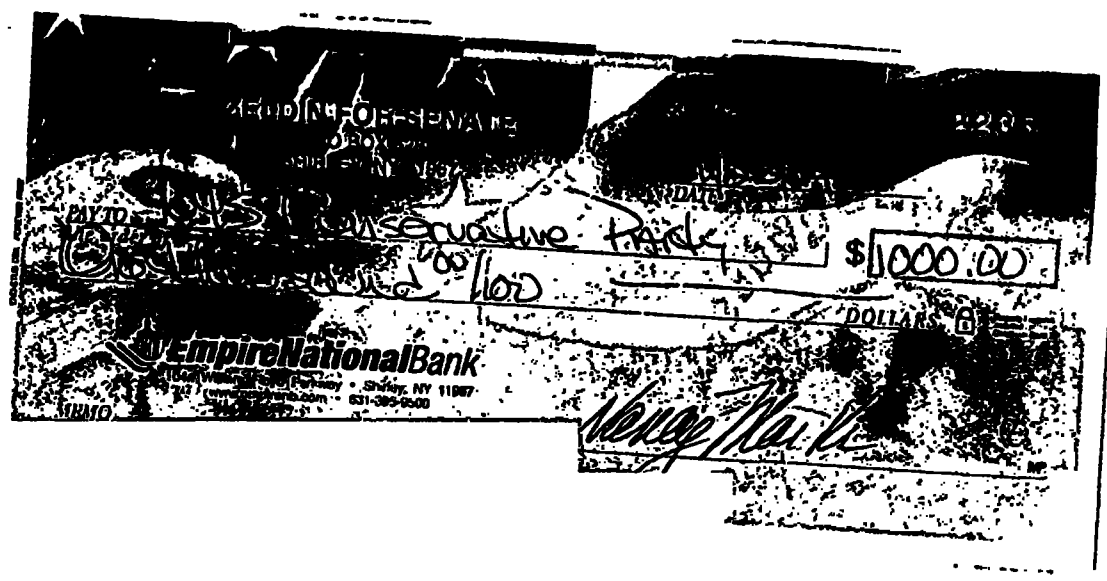
