This office represents Arizona Grassroots Action PAC and Lisa Lisker in her official capacity as Treasurer (collectively "Respondents") in the above-captioned MUR.

We have reviewed the Complaint filed by Dr. Michael P. Ward and Ward for Senate alleging that a mailpiece attached to the complaint failed to contain certain disclaimers required by the Federal Election Campaign Act of 1971 as amended ("FECA") and Commission regulations. The Arizona Grassroots Action PAC did not pay to produce or disseminate the mailpiece in question. Accordingly, there is no reason to believe that the Respondents violated the law and the Commission should promptly dismiss the Complaint against the Respondents.
