 - b. Find reason to believe that Unknown Respondents failed to include a proper disclaimer on the mailer, in violation of 52 U.S.C. § 30120(a); 11 C.F.R. § 110.11(a)(2).
 - c. Take no action at this time with respect to Arizona Grassroots Action PAC and Lisa Lisker in her official capacity as treasurer and the alleged failure to report independent expenditures, in violation of 52 U.S.C. § 30104(b)(4).
 - d. Find reason to believe that Unknown Respondents failed to report expenditures or independent expenditures, in violation of 52 U.S.C. § 30104(b) or (c).
 - e. Authorize the use of compulsory process, as necessary.

- c. Find no reason to believe that Arizona Grassroots Action PAC and Lisa Lisker in her official capacity as treasurer failed to report independent expenditures, in violation of 52 U.S.C. § 30104(b)(4).
- d. Dismiss the allegation that Unknown Respondents failed to report expenditures or independent expenditures, in violation of 52 U.S.C. § 30104(b) or (c).
- e. Approve the relevant portions of the Factual and Legal Analyses, as recommended in the First General Counsel's Report dated December 2, 2016.
- f. Approve the appropriate letters.
- g. Close the file as to Arizona Grassroots Action PAC and Lisa Lisker in her official capacity as treasurer.
