On May 3, 2016, the Americans for Sensible Solutions Political Action committee was organized by David Garrett at 8605 Santa Monica Blvd. in Los Angeles, California. This political action committee (PAC) is using the likeness of U.S. Representative Bill Huizenga without his permission to mislead Americans and sell merchandise.

The Americans for Sensible Edutions PAC runs the @HuizengaTrump16 Twitter account. This unauthorized account directs visitors to a Zazzle page selling "Huizenga Trump 2016 Unity Gifts." The gifts include mugs, shirts, buttons, key chains, hats, and sweatshirts. In addition, the @HuizengaTrump16 Twitter account encourages individuals to donate to the Americans for Sensible Solutions PAC via PayPal.

According to the Zazzle page, "This website is managed by the Americans for Sensible Solutions Political Action Committee along with the Republican Organization for Legislative Loyalty, and is intended to encourage unity between these two tremendous candidates and highlight the overwhelming similarity between their respective agendas and policy positions."

Neither Bill Huizenga nor Huizenga for Congress have authorized the Americans for Sensible Solutions Political Action Committee or the Republican Organization for Legislative Loyalty to use his name or his likeness.
