- d. Dismiss the allegations that Hillary for America and Elizabeth Jones in her official capacity as treasurer violated 52 U.S.C. §§ 30104(b)(3)(A), 30116(f) by knowingly accepting and failing to report excessive in-kind contributions from volunteer filmmakers.
- e. Dismiss the allegation that Hillary for America and Elizabeth
 Jones in her official capacity as treasurer violated 52 U.S.C.
 § 30120 by failing to include proper disclaimers on the Filmmakers
 for Hillary website and videos.
- f. Dismiss the allegations that Hillary for America and Elizabeth Jones in her official capacity as treasurer violated 52 U.S.C. §§ 30104(b), 30116(f) by knowingly accepting and failing to report an excessive in-kind contribution from another political committee.
- g. Dismiss the allegation that Hillary for America and Elizabeth
 Jones in her official capacity as treasurer violated 52 U.S.C.
 § 30125(e) by soliciting, receiving, directing, transferring, or
 spending non-federal funds arising out of its interactions with
 Priorities USA Action.
- h. Dismiss the allegations that Hillary for America and Elizabeth Jones in her official capacity as treasurer made, and Priorities USA Action and Greg Speed in his official capacity as treasurer knowingly accepted, unreported and excessive contributions, in the form of donor information in violation of 52 U.S.C. §§ 30104(b), 30116(a)(1)(C), (f).
- i. Dismiss the allegations that Jim Messina, Jonathan Mantz, and Paul Begala violated the Act in connection with Priorities USA Action's fundraising interactions with Hillary for America.

Commissioners Broussard, Cooksey, Dickerson, Trainor, Walther, and Weintraub voted affirmatively for the decision.
