We received the referral to the Office of the General Counsel in the above-captioned matter. Attached are Statement of Designation of Counsel forms for both Joni for Iowa and Cabell Hobbs in his official capacity as treasurer of Joni for Iowa. Incidentally, the package of materials received was missing the first page of the letter from Mr. Jordan. Would you kindly send me a copy of that page for my files?

Joni for Iowa received the referral in the Joni for Iowa Post Office Box on September 30, 2015. Accordingly, the response would be due on October 14, 2015. On behalf of respondents, we request a 30-day extension, until November 13, 2015 for two reasons. First, to give Joni for Iowa sufficient time to investigate the allegations made against respondents and prepare an appropriate response. Second, the compliance firm that has the information necessary to respond has a number of reports for other clients that are due to the Commission on October 15, 2015; Joni for Iowa will need their assistance to respond, which will be difficult to obtain prior to October 15.
