**COMPLAINT AGAINST JILL STEIN AND JILL STEIN FOR PRESIDENT FOR
ACCEPTING FOREIGN CONTRIBUTIONS IN HER CAMPAIGN**

INTRODUCTION:

I, Phillip James Wiglesworth, bring this complaint against Jill Stein, and her campaign, Jill Stein for President, and allege as follows:

I believe Dr. Jill Stein, and/or her campaign, "Jill Stein for President" (hereinafter, "JSFP"). Respondents, are using funds donated to her presidential campaign to conduct activities for the campaign, where some of those funds likely originated from non-U.S. citizens in foreign countries. I believe this is a violation of campaign finance rules outlined by the FEC.

Furthermore, upon information and belief, I feel that Respondent set out to mislead donors into believing they were only donating to help fund recount efforts, later "clarifying" that the money was going to be reserved by her campaign for the future, if the recounts proved to be under her budget or cost less than the amount raised. I believe this because after the donations website had exceeded its original stated goal of \$2.5 million, it was updated to a new goal of \$4.5 million

(and then later, \$7 million, and finally, \$9.5 million), and JSFP added several disclaimers^{1 2 3} to her site indicating that monies received in excess of what is required for the recounts could be used for other purposes in the future. In approximately one day, her campaign raised more money for the recount efforts than she had raised for her entire presidential run.⁴ See also, <http://www.zerohedge.com/news/2016-11-25/mysterious-case-jill-stein-s-surging-recount-costs> for an additional summary of other changes in her website, as well as strange facts surrounding the stated campaign goals and attorney's fees she said would be needed (article originally accessed on November 29, 2016).

There is one additional article claiming that a "bot" was helping ensure funds went into her donation account in the amount of approximately \$160,000 per hour on the hour during the first hours of the recount fundraising effort. I cannot vouch for the reliability of the author, or

substantially verify this information to be true or false, so I am submitting the reference to you for your consideration and potential investigation (<http://alexanderhiggins.com/soros-bot-funding-stein-recount-campaign-steady-rate-160k-per-hour/>):

According to the post donations to Jill Stein's election recount campaign are being made at a steady rate of \$160,000 on the hour every hour of the day.

The constant rate of donation, 24 hours a day, suggest that a computer program is being used to post the donations as opposed to real people making grassroots donation.

However, the donations are being reported as grassroots donations from a myriad of online supporters to help her verify the integrity of the election.

However, if real individuals are in fact making the actual donations they rate of the donations should drop over night when internet traffic is low.

The rate should then steadily pick up during the course of the day up and then culminate during the "internet rush hour" when usage peaks, which is usually between 7 and 11 PM.

Since this recount effort was initiated, Jill Stein has publicly claimed that the average contribution to her campaign was \$45, and that these are all "grassroots" donations. Additionally, she claims that there are over 130,000 contributions from "around the country."

"In true grassroots fashion, we're turning to you, the people, and not big-money corporate donors to make this happen. We have received over 130,000 donations averaging \$45 each from supporters around the country."

As of that time (11-29-16 at 10:39 am CST), the amount raised by JSFP for the "recount" is \$6,440,436.00. Upon hitting refresh on this webpage at 11:10 am CST, an additional \$5,000 had been raised in a matter of minutes, with \$6,445,441.00 total. By the next day, November 30, Stein's campaign had once again raised her campaign goal to 9,500,000 with the total amount of money raised at \$6,667,160.11 as of 12:48 pm CST.

As citizens who are concerned with the integrity of the elections, several of my contacts and I have been going through the public list of donors. Much to our dismay, we discovered that Dr. Stein is apparently accepting money from people in foreign countries. We feel that the influence of money from foreign donors undermines the U.S. electoral process.

RESPONDENT'S INTENT:

On November 23rd, Dr. Jill Stein began soliciting donations to her campaign online, including via her Twitter account, to support her effort for recounts in three states that went to her

opponent, Donald Trump, in the U.S. Presidential Election. Her stated goal was to file for recounts in the States of Wisconsin, Pennsylvania and Michigan, although it appears that she may have since missed her Pennsylvania deadline, whether intentionally or by accident.

Dr. Stein's rationale for the recount is apparently to make sure that no foreign countries have interfered with the U.S. Presidential election, a rationale bolstered by admittedly unverified claims which were made by the Obama administration and/or the Clinton campaign regarding "Russian interference" with voter registration and the election.

However, the FBI and the Department of Homeland Security stated that there is no evidence whatsoever that any hacking took place during the actual election.^{5 6} In addition, it is impossible for "hacking" to have occurred in Michigan, which runs on paper ballots and has nothing even connected to the internet to be hacked, according to a head Michigan election official.⁷

The FEC website outlines the reason for the ban on foreign contributions.⁸ If Jill Stein is to be believed that she cares about election integrity and fraud, she should immediately return any donations received from non-citizens. In light of the suspicions that foreign citizens could be donating, she should add a disclaimer to her website stating that all money accidentally received from foreign citizens will be immediately returned, since this is illegal. If she does not immediately make this change, the FEC should audit the integrity of these donations as soon as possible.

FACTS:

1. Dr. Jill Stein (Respondent) is a candidate for President of the United States as a member of The Green Party in the 2016 general election. Her campaign is known as "Jill Stein for President", or "JSFP". JSFP operates a website for the campaign which has been used to communicate with the public about Respondent's campaign, solicit electronically-processed donations for the campaign, and issue press releases to the public, both before and after the election took place. (<http://www.jill2016.com/>)
2. On November 23rd, 2016, Respondent announced that she was challenging the results of the election in the state of Wisconsin by requesting a recount of the votes in that state. At the same time, Respondent announced that the campaign required donations to help pay for that recount effort. Since Wisconsin state law requires the candidates' campaigns to pay for the recounts, the campaign would require more donated funds subject to FEC rules to support this effort. The JSFP website solicited these donations through the same website, under the same campaign disclaimer. (<https://jillstein.nationbuilder.com/recount>)
3. Because of the way the website is designed, anyone who donates money to the campaign is able to announce that they donated money through various social media platforms, including Twitter. As many thousands of people began to announce their donations to the recount effort, I began to notice that several people whose Twitter accounts claim to originate in foreign countries were announcing that they, too, donated to the JSFP campaign. In checking some of the names associated with those twitter accounts, background information on several of the individuals made it even more apparent that they are, in fact, residing in foreign countries. As well, some of those individuals likely are not U.S. citizens due to statements either made by themselves, published biographies, places of employment, etc. Since it cannot be verified at this time by a private citizen such as myself with certainty who all is a citizen and who all is not, a list was compiled of as many questionable Twitter accounts in foreign countries that may belong to non-U.S. citizens who donated to JSFP campaign as we were able to track down, with the intention of handing this list to someone with the capability of verifying citizenship, and enforcing our laws.

4. During the fundraising efforts for the recount, JSFP updated its fundraising goal from the original \$2.5 million estimate, to \$4.5 million, a \$7 million estimate, and finally, a \$9.5 million estimate as of November 30, 2016. This initial fundraising update was made even before Wisconsin announced to JSFP how much the recount effort was estimated to cost. JSFP updated their recount efforts to include Pennsylvania and Michigan, in addition to the original recount effort in Wisconsin.
5. On Monday, November 28th, 2016, Pennsylvania announced that the filing date to request a recount had already expired as of November 21st, 2016.⁹ Stein is now suing to try and get this recount, despite her apparent lack of planning and knowledge, and despite her ability to hire attorneys with the millions donated to her campaign for this effort.¹⁰ Additionally, even though Pennsylvania has denied Stein's request for a citizen recount due to missing the deadline of Nov 21st, Stein has not informed the public and/or donors of this fact, and continues to increase fundraising goals to include paying for a Pennsylvania recount. I believe this is intentional, ongoing public deception.¹¹

SUPPORTING DOCUMENTATION:

Included with this complaint is a copy of the spreadsheet (See Exhibit A, attached) where we recorded the known, publicly-visible details of the Twitter accounts belonging to possible non-U.S. citizens in foreign countries who claim to have donated to JSFP recount fundraiser. With each individual account, an included link to a web-archive of their public statement announcing that they donated to JSFP, as well as a web-archive of their main profile pages on Twitter, which list their alleged locations. Because Twitter allows users to remain private, this list is likely only a

partial list of those who are claiming to have donated, and it would be impossible for someone such as myself to access all of them.

This spreadsheet also includes web-archive links to JSFP recount page showing that the funding goals changed and disclaimers changed.

Copies of original, first-hand visual evidence have been safeguarded for the future via printing by multiple parties interested in adding their names as complainants via addenda, and many others, in an effort to prevent corporate censorship, obstruction of justice through deletion or editing, or otherwise any form of online tampering with any websites where we have sourced our information, whether on the part of the campaign, the owners of the sourced websites, or the Twitter account holders themselves.

PRAYER:

WHEREFORE, Complainant prays that the Federal Election Commission commence an investigation into whether Respondents have violated federal campaign laws through the above-mentioned activities, and render such other relief that the Commission may deem necessary, just, and equitable. Furthermore, the Respondent should be required to immediately submit a supplemental report regarding her campaign finances to clarify the sources of these contributions. The FEC should request that the JSFP campaign and Jill Stein immediately cease any and all recount efforts until such time as the integrity of the donors to her campaign can be confirmed. All other penalties, remedies or sanctions allowable by law should be enforced.

To wit, I, the, undersigned, submit the foregoing complaint and attached supporting documentation against Jill Stein and her campaign, Jill Stein for President.

I am a researcher in Artificial Intelligence working at Lancaster University from September 2016. My research is centered around the following areas and topics.

- Knowledge Representation and Reasoning
- Logic Programming
- Institutions
- Normative Multi-agent Systems
- Socio-technical System Governance

Specifically, my research focuses on prescriptions such as institutions (laws and contracts), societal and ethical norms, and social commitments (e.g. promises and the expectations they create). I look at such prescriptions from the perspectives of formalisation, automation and governance architectures.

Formalisation contributes rigorous mathematical accounts of previously vague concepts such as institutions and norms in order to understand those concepts and provide clear definitions that can be disseminated and criticized. Without formalisation, it is difficult to say in precise terms when a particular law or norm is in force and what the legal or ethical behavior is. This is a problem for both human and artificial agents. By formalising various types of prescription in a general way we are able to define how autonomous agents should, ideally, behave according to sets of legal and ethical norms and what the meaning of those legal and ethical norms is.

Automation takes formalisation one step further by devising appropriate specification languages and computational abstractions for norms, institutions and so on. Without automation, it is difficult to implement regulatory and normative behavior in a general way, at the abstract level of the written law, to govern societies and guide complex autonomous and distributed software systems in behaving ethically and legally. Moreover, legal and ethical norms are not necessarily easy to understand in precise terms for human agents. Hence, automation involves contributing software tools and reasoning mechanisms to support human and artificial agents in behaving appropriately according to legal and ethical prescriptions.

Governance architectures prescribe governance styles for managing socio-technical systems (e.g. social media, smart grids, sensor systems, etc.). The prescribed governance architectures deal with problems such as heterogeneity (how to govern societal participants that differ significantly in behaviors, capabilities, desires and intentions) and autonomy (how to govern autonomous societal

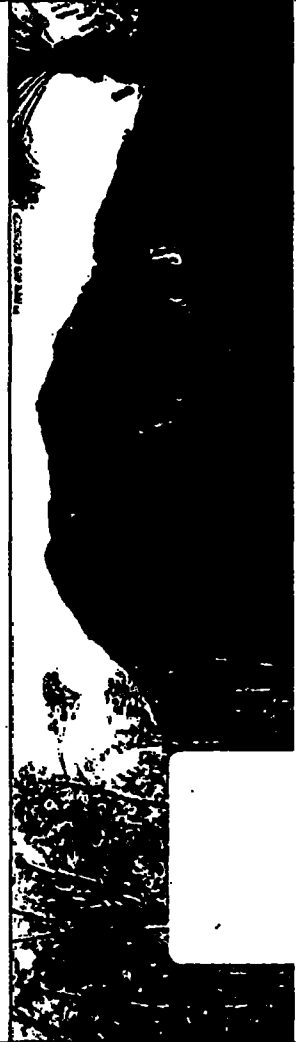
