I write today to file a complaint against the campaign committee Hoosiers for Jim Pfaff. This committee was organized for the candidacy of James R. Pfaff, for the 2016 election to the United States House of Representatives in the 9th congressional district of Indiana. Mr. Pfaff currently resides at Bloomington, IN, 47401.

Mr. Pfaff offered me, the complainant, the position of Deputy Campaign Manager on December 27, 2015 for a monthly compensation in the amount of \$3,500 (see Attachment 1). I have also attached the email communication with the campaign manager, Jadan Horyn to which the offer letter was attached (See Attachment 2). My employment began on January 18, 2016 in Smithville, Indiana. My work included scheduling and assisting Mr. Pfaff, making fundraising calls, submitting meeting requests, conducting donor research and correspondence, attending local Republican party meetings, among other duties.

I provided Mr. Pfaff with a detailed expense report on February 16, 2016 of campaign related expenses going back to October 2015, when I served in a voluntary capacity on the campaign, totaling \$639.68 (see Attachment 3). In October 2015, I was instructed to purchase pocket constitutions for the campaign at my expense and was told that I would be reimbursed by the campaign. I've attached the email communication showing this and highlighted the relevant portion (see Attachment 4).Mr. Pfaff never acknowledged the February 16 report or offered partial payment, even though he asked me to put meals on my personal credit card promising to repay me. One instance being the charge on February 2, 2016 to Golden China Restaurant in the amount of \$49.92.

After Mr. Pfaff failed to pay me the agreed upon monthly compensation or reimbursements, I left the campaign and moved back to Alexandria, Virginia on February 19, 2016. Despite continuous attempts to receive payment over the past year, Mr. Pfaff has not responded to any communications regarding payment. Attached is a letter personally handed to Mr. Pfaff on August 25, 2016 (see Attachment 5) as well as the email I sent him with the letter attached (see Attachment 6). This letter was accompanied by the original offer letter and expense report. His failure to respond or pay the \$4,139.68 that I am owed (\$3,500 for my month of services to the campaign and \$639.68 in itemized reimbursable expenses) has necessitated this official complaint.

Mr. Pfaff's failure to pay and his actions regarding this situation are in violation of multiple FEC laws. First, Mr. Pfaff has not reported my uncompensated services as debt as required by the FEC in 11 CFR 104.11(b) and 11 CFR 116.6. Additionally, if Mr. Pfaff believes I am not owed compensation, he has not properly reported to the FEC my requests for payment as required in 11 CFR 116.10(a).

Finally, I have not consented to or signed any statement agreeing for my uncompensated services to be converted to volunteer work, nor have I agreed to a settlement or forgiveness of this debt therefore I am entitled to payment for my services rendered.

I appreciate the General Counsel's office appropriately addressing this violation,
