Thank you for your time earlier today. As I mentioned, our firm represents Mr. Jared Kushner in connection with the complaint filed under matter MUR 7266.

We are in the process of completing the Statement of Designation of Counsel. As our client is overseas, however, and thus completion of that form may take some additional days, I wanted to email you in the meantime to confirm the request that I made on our call this morning for an additional 21 days (i.e. until September 14, 2017) to file Mr. Kushner's response to the complaint.
