GENERATION OF MATTER

This matter was referred by the Reports Analysis Division to the Office of the General Counsel on September 22, 1978. The attached referral notes that the reports for the period February 17, 1978 through June 30, 1978 show that the respondent Committee may have violated 2 U.S.C. §441a(f) by knowingly accepting the proceeds of an excessive loan.

EVIDENCE

The Committee's candidate, L. Brooks Patterson, is currently the prosecutor or district attorney of Oakland County, Michigan. He was elected to this position in an election held in 1977. His campaign for D.A. was run through a committee called the "Citizens Supporting L. Brooks Patterson," which was financed, in part, through several loans. Two of these loans, each in the amount of \$10,000, were issued to Mr. Patterson and his wife, jointly, and to a Richard Thompson, from the Michigan National Bank at an annual percentage rate of 11.52%. The proceeds were then loaned to the local campaign. This campaign also received an interest free \$10,000 loan from an Albert Thompson.

Mr. Patterson was successful in the race for D.A. and soon afterward, decided to challenge the incumbent Senator Griffin for the Republican nomination for the U.S. Senate in the 1978 election. Accordingly, the respondent Committee was established. However, the three aforementioned loans had not been retired and were assumed by the respondent Committee (see report excerpt, attached).^{1/} Mr. Patterson lost his Senate bid, polling 22.1% of the vote.

^{1/} The report gives the dates of these loans as 3/29/78. It is believed that this is the date on which the respondent Committee assumed the liability for these loans.

PRELIMINARY LEGAL ANALYSIS

While these loans are in violation of the limits imposed by 2 U.S.C. §441a(a) and were accepted in apparent violation of 2 U.S.C. §441a(f), they were not made, initially, to the respondent but to an unrelated local campaign committee. The respondent did not receive the proceeds of these loans, but merely agreed to assume the obligation to repay them. Upon being advised, on June 1, 1978, that an agreement to repay loans which would have been violations of the Act if made to a Federal campaign committee was itself a violation of Federal law, the respondent Committee revoked its assumption of these debts (see attached mailgram), thus bringing it into compliance with the Act voluntarily. In view of these circumstances we believe no further action is warranted.

RECOMMENDATION

Take no further action and close the file on this matter.

As a result of a newspaper article quoting me, I received a call from a candidate's aide. I gave them some general advice, and probably they will be filing amended reports. This memo is to relate to you the circumstances.

The Detroit News called me about the reports of candidate L. Brooks Patterson, and asked about the federal reporting and limitation requirements in transferring money from a prior state office election, and in assuming a debt from a prior state office election.

I discussed the transfer rights of 110.3(a)(2)(iv), and the specific application of 104.10 in how a state committee would figure out the actual contributors involved in the transfer and how contributions over federal limits would have to be excluded. I said that the question of whether the federal committee could assume a loan debt to an individual of more than the contribution limit was a novel one that might require an AO, but that we had issued an advisory opinion (77-38) indicating that a state committee could keep fund-raising for the past state debt separate. I strongly indicated that any problems were somewhat technical, easily corrected by amended reports, and that the campaign should get in touch with us if they did not fully understand the transfer rules. The news article today did refer to the question, and did quote me as indicating that what they were doing might involve technical discrepancies.

I then received a call from Richard Thompson, who is an assistant to the candidate in the prosecutor's office, and who is also the son of the donor described above who had made the \$10,000 loan that is being carried as a debt. (Thompson's number is 313-858-0646, address Courthouse Tower, Pontiac Mich, 48053) He stressed that they were not aware of the transfer technicalities, that they in no way wanted to be in any discrepancy situation, and he asked what they should do to be in strict conformity.

On the first point, the surplus funds, he indicated that it basically was made up of the \$10,000 loan, which he said was being held to pay campaign debts on an installment basis. I explained that 104.10 would only allow \$1,000 to be transferred. I explained that the best thing to do would be to transfer either the entire sum, or \$1,000, back to a state campaign debt committee.

On the second point, assuming a debt, I said that we simply could not give a definite answer in an area like that which is somewhat gray, but that often our policy would be to suggest other ways to accomplish the same objective that pose no problems or questions. I then cited, and mailed to him, AO 77-38 (Hastie, for candidate Ravenel) indicating that the state campaign debt could be kept separate in all respects. I also sent him the Rep. Rogers AO, 77-63, showing the same kind of requirements cover transferring pre-76 and pre-71 campaign. I indicated that the assumption of these debts could also be transferred back.

In general, I advised him to clean-out all prior state campaign financial transactions from the federal senate race, and follow AO 77-38 in terms of paying off any prior campaign debts. I said they could transfer the items back. I did not discuss in any way how that should be reported. They will probably need help in exactly how that should be accomplished and reported.

Your committee's April 10 report indicates a transfer of funds between the candidate's previous campaign committee and his present principal campaign committee. Please be advised that Section 110.3(a)(2)(iv) of the FEC Regulations states that a transfer of funds between a candidate's previous campaign committee and his or her currently registered principal campaign committee or another authorized committee is permissible as long as none of the funds transferred contain contributions which would be in violation of the Act.

FEC Regulation, Section 104.10 requires that political committees and candidates which have cash on hand at the time of registration (which the committee or candidate anticipates using in an election) shall disclose on their first report the source(s) of these funds, (in this case the \$8,315.01 transferred from the Citizens Supporting L. Brooks Patterson Committee to the Patterson for Senate Committee). The cash balances are assumed to be composed of the most recently received funds by the committee or candidate. The committee shall exclude from funds to be used for Federal elections any contributions not permissible under the Act.

Sections 110.4(a)(1), 114.2 and 115.2 of the FEC Regulations prohibit contributions to a Federal campaign committee by national banks, corporations, labor unions, Federal government contractors or foreign nationals. Consequently, any funds contributed from such sources and transferred to the Federal campaign committee must be returned to the State campaign committee. Also, Section 110.1(a)(1) requires that contributions by individuals to any candidate or his or her authorized political committee to any election to Federal office in the aggregate shall not exceed \$1,000.00.

Please provide the required information disclosing the sources of the \$8,315.01 transferred from the State committee to the present registered principal campaign committee - Patterson for Senate.

This letter is prompted by the Commission's interest in assisting candidates and committees who wish to comply with the Federal Election Campaign Act, as amended. During review of the April 10 Report of Receipts and Expenditures, we noticed entries indicating that you may have received contributions which exceed the limits set forth in the Act. A copy of that portion of your report is attached so that a review of your records can be made.

The Act precludes individuals from making political contributions to a candidate for Federal election in excess of \$1,000 per election.

The Commission recommends that if you find the contributions you received were in excess of the limits set forth in the Act you return the amounts in excess of \$1,000 to the donors. These returns should be reported immediately by letter and should be reflected as contribution refunds on your next reports of receipts and expenditures. If you find that the entries in question are incomplete or incorrect, please submit a statement which would clarify these particular matters for the public record. You may do so by amending your original report by letter.

Please notify the Commission within fifteen (15) days from the date of this letter of the determination made on these matters. If you have any questions concerning these matters, please do not hesitate to contact Bill Coppel (800)424-9530, our Reports Analyst assigned to you. Our local telephone number is 523-4048.

Mr. Davidson called to provide an explanation for the questions asked in the RFAI sent on June 1, 1978. The reason given for the delay in responding was that he had just received the request. (the request was sent to the campaign office which is not in Mr. Davidson's usual course of travel.)

Paragraph 2 of the RFAI:

Citizen for L. Brooks was started by opening an account with a loan of \$10,000 from Albert Thomson. The purpose of this committee was to pay off old debts from the D.A. race and to provide an expense account for various purposes i.e. travel, dinner, tickets for events and other occasions that may arise, for Mr. Patterson.

Previous committee - Committee that was used in the race for the D.A. office. This committee was formed and financed by a loan of \$10,000 from L. Brooks and Kathy (his wife). This loan also included interest charges which amounted to about \$2000.00. Also there was another loan from Richard Thomson of 10,000 plus interest. This money was used to pay off "old debts" and debts from the D.A. race. ~~XXXXXXXXXX~~ The entire amount of the \$20,000 was used, leaving a substantial amount of debts.

Between the dates of 7/77 and 12/31/77 about \$27,000 was raised through various activities. This was done by Mr. Davidson in his capacity as treasurer of the Patterson for Senate Committee. This money was used to continue to pay off debts from the D.A. race and also current expenses as well as payments on the two \$10,000 loans explained above. *(L. Brooks, Kathy and Richard Thomson)*

Once the debts from the D.A. race were paid off, \$8,315.01 was left. However, the debts for the two \$10,000 loans were not extinguished. An exact figure is known at this time.

First in first out accounting of the \$8,315.01:

Mr. Davidson said that to the best of his knowledge, the funds in the amount of \$8,315.01 contain no illegal contributions. The only thing he was not sure of was the possible contributions from unions (labor), of about \$200. This does not constitute adequate disclosure, but I did not tell this to Mr. Davidson because I wanted to review all the information together.

The committee ran out of money, so Mr. Davidson issued them a loan of about \$1923.00 to get them by. In MI, committee set up for the purpose of a ballot question can accept corporate contributions. Consequently the money raised to repay the loan of \$1923.00 contains corporate contributions. I said that I would get back to him with further directions.

SUBJECT: REFERRAL OF NON-CORPORATE AND NON-UNION CONTRIBUTIONS
WHICH EXCEED THE LIMITATIONS OF THE ACT

To insure a uniform procedure for referral of contributions in excess of allowable limitations the following procedures will apply. (This does not apply to corporate/union contributions which are presently handled in accordance with the Commission's March 16, 1978 decision).

1. All apparent contributions in excess of the applicable limitations will be processed in our normal compliance track. (Surface violation letter, reason to believe, referral).
2. If, during the compliance process, the recipient acknowledges the excessive contribution and corrects the violation, the following procedures will be followed:
 - A. If the excessive contribution is less than \$500, compliance will be considered achieved and the matter closed in accordance with existing Reports Analysis Division procedures.
 - B. If the excessive contribution is \$500 or more, a referral will be made of this specific contribution to the Office of General Counsel for their review and possible consideration for initiation of a MUR.
3. If an adequate response is not received during our present compliance process, the matter would be referred in accordance with our existing procedures.

This procedure does not change existing policies for placing matters on the public record. If you have any questions on these procedures or the implementation of these procedures feel free to contact me.
