I would like to make a formal complaint against the Libertarian Party of Miami-Dade (LPMD) and Libertarian Party of Florida (LPF) Chairperson Marcos Miralles. The LPMD has a non-citizen and possible undocumented alien, named Pierre-Alexandre Crevaux, in an elected to managerial & decision making position within the LPMD, with the full knowledge that this is against the Advisory Opinions of the FEC. Additionally, this individual, in his position as Executive Director of the LPMD, he has repeatedly been involved in Federal Electoral Activity in a managerial & decision making position. Additionally, LPMD board member & LPF Chair Marcos Miralles has appointed Mr Crevaux as his Chief of Staff and has granted Mr Crevaux supervisory powers, and has actively attempted to cover-up the legality of Mr Crevaux's involvement. Additionally, per public records, Mr Crevaux has made financial donations to political campaigns, including a \$100 donation to the LPMD, and a \$38 donation to the gubernatorial campaign of Adrian Wyllie in 2014 (screenshots of both provided). Additionally, in 2018, when Mr Crevaux attempted to make a \$5 donation to the LPF, the LPF acknowledged the illegality of this action and acknowledged they would be subject to FEC actions (screenshots provided). The LPF has taken great lengths to attempt to cover up this information. These incidents are a clear violation for FEC AOs and Federal Statutes, therefore as a good citizens, I wish to file a formal complaint and bring this to your attention.



Section 5

There shall be an Executive Director, whose duties and responsibilities shall be:

- (a) Overseeing the works of the Standing Committees;
- (b) Assisting the Officers with their respective duties;
- (c) Helping Executive Committee members with their responsibilities and facilitating communications between Executive Committee members;
- (d) Assigning membership to a Standing Committee for all Precinct Delegates that have not joined a Standing Committee within (15) days of the beginning of the term of such Precinct Delegates;
- (e) Serving as interim Standing Committee Director in the event of a vacancy;
- (f) Redacting some public records to protect essential secrecy of the Affiliate's works, as described in Article X, Section 2 of these Laws; and
- (g) Providing rules on the request for proposal process for the procurement of goods and services, as described in Article XI of these Laws;
- (h) Appointing at most one (1) Precinct Delegate to the Convention Committee once called into session;
- (i) Serving on the Committee of the Whole; and
- (j) Performing any other duties as assigned by the Chairperson or the Executive Committee.
