To Whom It May Concern:

It has come to my attention that Matlock for Congress, the congressional campaign committee for Jimmy Matlock in Tennessee's 2nd Congressional District (FEC ID # C00652396), has violated federal law by accepting contributions from corporations during the fourth quarter of 2017 filed on Jan. 31, 2018.

According to the FEC's website, "Campaigns are prohibited from accepting contributions from certain types of organizations and individuals. These prohibited sources are: Corporations, including nonprofit corporations."

On pages 43 – 44, the recipient committee (Matlock for Congress) reports contributions from Lange Animal Hospital and Lenoir City Animal Clinic (See source documents on pages 4 and 5):

a. Lange Animal Hospital: \$500, 10/19/17

b. Lenoir City Animal Clinic: \$500, 12/18/17

The Tennessee Secretary of State's website demonstrates that both companies have filed as corporations – and are explicitly prohibited from donating to federal campaigns.
