Dear Ms. Stevenson,

This is a complaint directed at former presidential candidate Hillary Clinton, Hillary Victory Fund (HVF), her 2016 campaign committee for President and the Democratic National Committee (DNC) for apparent Campaign Finance law violations in the 2016 presidential election which merit investigation and prosecution. We urge the FEC to launch such an investigation of the above entities and individuals as are warranted.

The information in this complaint is based on information and belief based on media reports. Our original filing of 12/22/2017 is attached and also relies on information and belief based on media reports.

The documentation of these new charges comes from Donna Brazile, then Democratic National Committee interim chairman and her book "Hacks," which outlines the scheme by the Hillary Clinton presidential campaign to evade campaign finance limits starting in 2015.

Brazile revealed that Hillary's presidential campaign had a written - but secret - agreement with the Democratic National Committee to violate Federal Election Campaign limits through a series of transactions designed to hide their illegal campaign activities.

According to Brazile, Hillary Clinton helped raise \$82 million through joint fundraising agreements, supposedly for state Democratic party organizations. But then this money was illegally re-routed back to the Hillary for President campaign in their hidden deal, clearly violating both the spirit and the actual FEC law.


