Re: MUR 7327 and MUR 7337 – Request for Extension of Time

Dear Ms. Ross:

I write on behalf of Respondents Debbie Lesko, Debbie Lesko for Congress, Re-Elect Debbie Lesko for Senate, and Ashley Ragan in her official capacity as treasurer of Debbie Lesko for Congress (collectively, the “Lesko Respondents”) in connection with Matters Under Review (“MUR”) 7327 and 7337. Enclosed please find executed Designation of Counsel forms for each of the Lesko Respondents.

Because the complaints filed in the two matters concern the same alleged underlying transactions and occurrences, the Lesko Respondents intend to file a consolidated response that will address the claims set forth in both complaints, and respectfully request that the time in which they may respond to both complaints be extended until the close of business on **Wednesday, April 25, 2018**. The proposed deadline would represent an extension of 30 days of the deadline to respond to the complaint in MUR 7337 and an extension of 37 days of the deadline to respond to the complaint in MUR 7327.

The two complaints collectively present at least four distinct questions of campaign finance law. The requested extension will ensure that the Lesko Respondents and their counsel are afforded sufficient time to prepare a comprehensive and detailed response to both complaints, particularly given the demands placed on the Lesko Respondents’ time and resources by the upcoming special general election in Arizona’s Eighth Congressional District, which will be held on April 24, 2018.
