RESPONDENTS’ REPLY IN OPPOSITION TO THE GENERAL COUNSEL’S BRIEF

Respondents Debbie Lesko and Re-Elect Debbie Lesko for Senate (the “State Committee”), respectfully submit this response to the General Counsel’s Brief. It is undisputed that the State Committee, a non-federal committee organized to support Congresswoman Lesko’s prior candidacies for the Arizona Legislature, made on or around January 18, 2018 a contribution of \$50,000 to Conservative Leadership for Arizona (“CLA”), a federal, independent expenditure-only political action committee.

The Office of General Counsel’s (“OGC”) argument that there is “probable cause” to believe that the transfer violated 52 U.S.C. § 30125(e)(1)(A) is constructed on three consequential errors.

First, OGC concludes that a federal candidate “finances” an entity, within the meaning of 52 U.S.C. § 31025(e)(1), if she makes or directs a contribution that *post hoc* hindsight reveals constituted a majority of the recipient’s overall revenues. In other words, OGC’s conception of the “financing” rubric would effectively condition the lawfulness of a transfer on clairvoyance or luck.

Second, OGC appears to argue that the transfer to CLA was unlawful because the \$50,000 sum exceeded the \$5,000 limit that governs contributions solicited by federal candidates. But this reasoning flies in the face of an accretion of Commission guidance—including, ironically, the very Matter Under Review that OGC cites in support of its novel proposition—consistently holding that, when a candidate makes or directs a transfer in connection with a federal or state election, the permissibility of the transaction pivots *not* on the aggregate amount, but rather on whether the *underlying funds* comply with the applicable federal strictures. In this vein, it is (or should be) undisputed that the \$50,000 transferred to CLA was assembled from funds that complied with federal amount limits and that had originated only from federally permissible sources. *See* MURs 6563/6733, Factual & Legal Analysis -- Rep. Eric Cantor and ERICPAC (Dec. 8, 2015).

Third, in seeking to premise liability on its contention that the \$50,000 transferred to CLA did not comply with federal “reporting requirements,” within the meaning of 52 U.S.C. § 31025(e)(1)(A), OGC attempts to penalize the Respondents for the Commission’s inability to supply the regulated community with a consistent and self-contained construction of the “reporting requirements” prong of 52 U.S.C. § 30125(e)(1)(A). As detailed below, various Commissioners have over the years proffered no fewer than *four* mutually inconsistent explications of the “reporting requirements” standard, two of which postdated the Respondents’ transfer to CLA. While the Respondents would welcome, and will commit unequivocally to adhere to, clear regulatory parameters denoting the

“reporting requirements” concept, due process requires, at the very least, fair notice of their terms.

FACTUAL BACKGROUND

The OGC’s characterization of the Respondents’ statement of the material underlying facts, *see* OGC Br. at 2-5, is largely correct. The Respondents wish, however, to underscore three points.

First, Congresswoman Lesko did not participate, directly or indirectly, in the establishment, governance, activities, or expenditures of CLA, and at the time of the transfer had no knowledge of whether it had received or would receive financial support from sources other than the State Committee.

Second, as OGC acknowledges in footnote 48 of its brief, prior to making the transfer, the State Committee performed a “last in, first out,” analysis of its cash on hand, for the purpose of identifying and filtering out funds that did not comply with the then-applicable federal contribution limits or that had originated from sources (*e.g.*, Arizona state political committees) that may not qualify as permissible under the Federal Election Campaign Act of 1971, as amended (the “Act”).¹ Documentation of the LIFO accounting—which the Respondents long ago provided to OGC—is attached to this brief.

¹ At all times relevant, Arizona law has prohibited contributions to candidates for state or local office from corporations, limited liability companies or labor unions. *See* Ariz. Rev. Stat. § 16-916(A). The State Committee accordingly has never possessed funds attributable to such entities.

Third, despite OGC’s inclusion of seemingly tangential and superfluous arguments in its submission (*see, e.g.*, OGC Br. at 12 (implying that the amount of the State Committee’s transfer to CLA was excessive)), the ***only*** issue on which OGC has actually requested a finding of probable cause is the question of whether the transferred funds complied with the “reporting requirements” prong of 52 U.S.C. § 30125(e)(1)(A). *See* OGC Br. at 14.

LEGAL ANALYSIS

A federal candidate or officeholder, or any entity “directly or indirectly established, financed, maintained or controlled” by her, may not “solicit, receive, direct, transfer, or spend funds in connection with an election for Federal office . . . unless the funds are subject to the limitations, prohibitions, and reporting requirements of this Act.” 52 U.S.C. § 30125(e)(1)(A). The State Committee was established, financed, maintained, and/or controlled (“EFMC”) by Congresswoman Lesko.

The fulcrum of this dispute is whether the \$50,000 transferred by the State Committee to CLA was “subject to the . . . reporting requirements” of the Act. Given that OGC’s theory of liability apparently is predicated solely on this facet of subsection (e)(1)(A), OGC’s exertions to establish that Congresswoman Lesko EFMC’d CLA (as distinguished from the State Committee) appear to be somewhat superfluous. If the transferred funds were in fact compliant with section 30125(e)(1)(A)—and, for the reasons

set forth below, they were—then it is immaterial whether Congresswoman Lesko EFMC’d CLA.²

In any event, Congresswoman Lesko did not “finance” CLA via the State Committee because she did not know—and had no way of knowing—whether or to what extent CLA would garner financial support from third parties. Further, the transferred funds complied with 52 U.S.C. § 30125(e)(1)(A) because, as monies that were obtained and reported by an Arizona committee in accordance with Arizona state law, they were not non-compliant with a controlling federal reporting mandate. Crucially, “[t]he requirement that a state or local candidate officeholder pay . . . with money subject to FECA limits, prohibitions, and *reporting* requirements does *not* establish a reporting requirement that would not otherwise exist.” MUR 5604 (William D. Mason) Statement of Reasons of Commissioners Toner, Mason and von Spakovsky (Dec. 11, 2006) at 5-6. Each point is addressed below.

² To be sure, if CLA had received funds from third parties, then—if it were an EFMC’d entity—the origins and amounts of such contributions could have regulatory implications. But, according to OGC, no more than \$50 of CLA’s receipts originated from sources other than the State Committee. *See* OGC Br. at 10. According to Commission records, CLA terminated its existence on August 26, 2021 without ever accepting additional contributions. Further, even if underlying contributions to the State Committee were to be aggregated with contributions by the same donors to Congresswoman Lesko’s authorized campaign committee, Debbie Lesko for Congress, during the 2018 election cycle, the State Committee still had sufficient federally compliant cash on hand to comprise its transfer to CLA. Stated another way, no given underlying donor to any of the relevant entities contributed more than \$2,700 per election in the aggregate or was prohibited by federal law from making a contribution.

I. Congresswoman Lesko Did Not “Finance” CLA

According to OGC, “[t]he key factor” in determining whether Congresswoman Lesko “financed” CLA is “whether Lesko provided funds ‘in a significant amount on an ongoing basis’ to CLA.” OGC Br. at 8. To that end, it appears to be undisputed that neither Congresswoman Lesko nor the State Committee remitted funds to CLA “on an ongoing basis;” rather, their financial support consisted of a one-time transfer of \$50,000. *Contrast NPRM: Prohibited and Excessive Contributions; Non-Federal Funds or Soft Money*,” 67 Fed. Reg. 35654, 35658 (May 20, 2002) (emphasizing that the “financing” prong of the EFMC’d rubric encompasses not only the “magnitude” of the financial support, but also the “frequency, and duration of funding,” adding that “a sponsor that had provided a sizable, but one-time contribution to an entity many years earlier would be able to assert that the one-time nature of the contribution, combined with its remoteness in time, make this funding not ‘significant’”); Adv. Op. 2004-41 (CUNA Mutual) (finding no affiliation between corporate entities, explaining that “although CUNA Mutual provided a one-time \$50,000 payment to CUNA’s Administrative Fund to further its political advocacy efforts, CUNA Mutual has not made any other similar payments and it intends none in the future”); *contrast* MUR 5367 (In re Darrell Issa, *et al.*), First General Counsel’s Report (Nov. 5, 2003) at p. 11 (finding that federal candidate “financed” entity, where he and entities he controlled provided donations to state recall committee “regularly - indeed, almost weekly . . . indicating that the donations were made on an ‘ongoing basis’”).

OGC’s argument that the Respondents “financed” CLA is predicated primarily on Advisory Opinion 2006-04 (Tancredo), in which the Commission concluded that a federal candidate would be deemed to have “financed” a ballot measure committee if he knowingly provided 50% of the organization’s overall funding. By contrast, the Respondents possessed no information concerning CLA’s budget or operations; they did not know—and had no means of knowing—what percentage of CLA’s aggregate revenues the State Committee’s contribution would ultimately represent or CLA’s intended lifespan.

The notion that a federal candidate can accidentally “finance” a committee by happenstance solely as a consequence of extrinsic factors and *post hoc* developments outside her control collides with the Commission’s precedents, the animating purposes of the Act, and basic common sense. *See* MUR 6753 (People for Pearce), First General Counsel’s Report (Jun. 20, 2014) at pp. 6-7 (recommending dismissal of allegation that federal candidate “financed” non-connected political committee, in part because the candidate and recipient PAC “were unaware that their funds would constitute a significant portion of [the PAC’s] receipts and have submitted [a] sworn affidavit . . . in support of that claim”).³

³ OGC purports to distinguish MUR 6753 on the grounds that the recipient committee refunded the contribution and “did not disburse any funds for substantive, non-administrative expenses before refunding it.” OGC Br. at 9 n.41. But this reasoning only illuminates the untenability of OGC’s position because it makes a candidate’s regulatory exposure contingent upon the actions and decisions of an entity that the candidate does not—and, crucially, *cannot*—control. Put another way, under OGC’s paradigm, a federal

As then-Commissioner Goodman explained:

An arms-length contribution—even a large contribution—from a candidate’s campaign committee or leadership PAC to an independent expenditure committee may be a form of financial support, but it does not constitute the kind of financial control over non-federal funds which is the focus of the statute. The candidate or officeholder must exercise a significant degree of control of the recipient organization beyond the mere provision of financial support in order for an organization to be ‘financed’ by the candidate as contemplated by the statute.

Policy Statement of Commissioner Lee E. Goodman, Feb. 16, 2018.

Commissioner Goodman’s construction is conceptually and logically sound. The “financing” element of the EFMC’d rubric can be sensibly (and constitutionally) applied only if it incorporates a prerequisite of—if not control—then at least contemporaneous *knowledge*. In other words, a candidate who makes or directs an isolated and otherwise compliant contribution to a third party entity cannot be charged with “financing” the latter unless she knew (or at least had reason to know) that the contribution would constitute a majority or some other substantial proportion of the entity’s overall receipts.⁴

candidate who makes a donation to a non-connected entity can ensure that she does not inadvertently “finance” the recipient only by either (i) wagering that the recipient’s efforts to cultivate larger contributions from third parties will prove sufficiently fruitful or (ii) exerting control over the recipient’s financial and operational decisions, which, in turn, presumably would have the perverse effect of rendering the recipient “maintained” and/or “controlled”—if not also “financed”—by the federal candidate.

⁴ Consistent with the Commission’s prior guidance, the remittance of multiple, sizeable contributions on an ongoing basis could, depending on the circumstances, indicate knowledge that the support would represent a determinative percentage of the recipient’s total revenues.

II. The Funds Transferred by the State Committee to CLA Complied with the Act's Limitations, Prohibitions and Reporting Requirements

A. The Transferred Funds Originated Only From Individuals in Amounts That Did Not Exceed \$2,700

OGC's theory of liability appears to be that the State Committee's transfer to CLA was unlawful because the \$50,000 in funds that comprised the transaction were not "subject to the . . . reporting requirements" of the Act. 52 U.S.C. § 30125(e)(1)(A). Its brief, however, embarks on a seemingly tangential and gratuitous argument that the transfer also contravened the Act's source and/or amount limitations. *See* OGC Br. at 12.

This contention, however, is factually incorrect and legally meritless. As noted above (and as OGC appears to concede), the Respondents used "last in, first out," which the Commission has deemed a "reasonable accounting method," to identify and exclude from the transfer underlying donations to the State Committee that had originated from federally impermissible sources or that had exceeded federal contribution limits. *See* Adv. Op. 2007-26 (Schock); *see also* Adv. Op. 2006-38 (Casey); Adv. Op. 2005-05 (LaHood).

OGC proffers two counterarguments. First, OGC notes that Advisory Opinion 2007-26 "addressed a federal candidate's state committee contributing funds to other *state* committees, not to a federal committee EFMC'd by the federal candidate." OGC Br. at 11. But—excepting the "reporting requirements" criterion, which Respondents will address below—transfers by federal candidates to state committees are encumbered by precisely the same regulatory restrictions as transfers to other federal committees. Specifically, in

both scenarios, the transferred funds must comply with federal source and amount rules. *Compare* 52 U.S.C. § 30125(e)(1)(A) *with* 52 U.S.C. § 30125(e)(1)(B). If the use of LIFO to extract federally impermissible funds discharges this burden in the context of transfers to state committees, nothing in the statutory text could possibly sustain a different finding in connection with transfers to federal committees.

Second, OGC cites MURs 6563/6733 (Schock), where respondent Schock, a federal candidate, had solicited contributions of \$25,000 to a federal independent expenditure-only committee. *See* OGC Br. at 12. But to the extent any plausible analogy to MURs 6563/6733 can be forged at all, Congresswoman Lesko is similarly situated to then-Representative Eric Cantor, whose leadership PAC—an entity that Representative Cantor had, by definition, EFMC’d, *see* 11 C.F.R. § 100.5(e)(6)—***made*** the \$25,000 contribution at issue. Notably, the Commission unanimously found no reason to believe that Representative Cantor had violated any provision of the Act because although the aggregate total of his leadership PAC’s contribution far exceeded the \$5,000 limit that governs federal candidates’ solicitations of contributions to independent expenditure committees, the underlying funds comprising the transfer complied with federal source and amount limits. *See* MURs 6563/6733, Factual & Legal Analysis – Rep. Eric Cantor and ERICPAC (Dec. 8, 2015).⁵

⁵ OGC constructs its argument almost exclusively on Advisory Opinion 2011-21 (Constitutional Conservatives Fund)—but there, the Commission held that a leadership

More generally, the Commission has repeatedly informed the regulated community that the operative query in this and similar contexts is whether the constitutive funds transferred by a federal candidate (or entities under her control) qualify as “hard” dollars; the cumulative total transferred is immaterial. *See* Adv. Op. 2007-26 (Schock); Adv. Op. 2007-29 (Jackson) (concluding that the Act imposes no aggregate limit on permissible transfers by a federal candidate, as long as the underlying funds are federally permissible); Adv. Op. 2012-34 (Freedom PAC and Friends of Mike H) (permitting federal candidate committee to transfer \$10,000 to federal independent expenditure-only committee).

B. The Funds Transferred to CLA Were Compliant With the Act’s Reporting Requirements

It appears to be undisputed that CLA disclosed to the Commission its receipt of the transfer from the State Committee, whose underlying donors were, in turn, publicly reported to the Arizona Secretary of State in accordance with Arizona law.⁶ Because the State Committee did not neglect any federal reporting requirement, the transfer was

PAC “may not receive unlimited funds from any individuals or any funds from corporations or labor organizations.” In other words, the committee could not solicit or receive underlying funds that constituted “soft money.” For that reason, Representative Schock in MURs 6563/6733 could not solicit individuals for contributions of more than \$5,000. Here, by contrast, the State Committee’s transfer to CLA was a *composite* of funds that uniformly consisted *only* of underlying donations from individuals of \$2,700 or less.

⁶ Arizona law at the time required candidate committees (such as the State Committee) to itemize all individual contributions in excess of \$50 for the two-year election cycle. *See* Ariz. Rev. Stat. § 16-926(B)(2)(b) (2018).

compliant with 52 U.S.C. 30125(e)(1)(A). As a controlling bloc of the Commission has explained:

The requirement that a state or local candidate officeholder pay . . . with money subject to FECA limits, prohibitions, and *reporting* requirements does *not* establish a reporting requirement that would not otherwise exist. In other words, if, for example, FECA does not otherwise require a state or local candidate or officeholder to report, then the candidate or officeholder need not do anything to comply with the ‘reporting requirement’ language of Section [30125(f)(1)]. Such a candidate or officeholder complies with this language by not reporting.

MUR 5604 (William D. Mason), Statement of Reasons of Chairman Michael E. Toner and Commissioners David M. Mason and Hans A. von Spakovsky at 5-6 (Dec. 11, 2006) [internal citation omitted; emphasis in original].

OGC musters two anemic responses. First, it asserts that the statutory provision at issue in MUR 5604 (*i.e.*, the current 52 U.S.C. § 30125(f)(1)) and the controlling provision here (*i.e.*, 52 U.S.C. § 30125(e)(1)(A)) “apply to different actors.” OGC Br. at 14. With due respect to OGC, this argument is unpersuasive to the point of incoherence. The operative language in both clauses is—exactly and verbatim—the same. Specifically, both federal candidates (per subsection (e)(1)(A)) and state or local candidates (per subsection (f)(1)) may spend in connection with certain federal election-related activities only funds that are “subject to the limitations, prohibitions, and reporting requirements of th[e] Act.” If OGC is actually contending—seriously and in good faith—that the same words mean two different things, then such an extraordinary discovery, if ratified by the Commission,

can be effectuated only prospectively, and certainly must entail a more detailed explication of how the same words are susceptible to two divergent applications. After all, due process demands that “regulated parties should know what is required of them so they may act accordingly.” *Fed. Commc ’ns. Comm ’n v. Fox Television Stations, Inc.*, 567 U.S. 239, 253 (2012).

Second, OGC retorts that “[a] majority of the Commission did not approve the position articulated in this MUR 5604 SOR.” OGC Br. at 13. Preliminarily, “[t]he D.C Circuit has long held that the reasoning from a statement issued by controlling commissioners constitutes the reasoning of the Commission ‘since their rationale necessarily states the agency’s reasons for acting as it did.’” MUR 7454 (Blue Magnolia LLC), Statement of Reasons of Chairman Dickerson (Apr. 14, 2022) (quoting *Democratic Cong. Campaign Comm. v. Fed. Election Comm’n*, 931 F.2d 1131, 1134-35 (D.C. Cir. 1987)). Further, OGC’s argument elides the fact that a majority of the Commission has *never* approved *any* single construction of the “reporting requirements” prong. To the contrary, various permutations of Commissioners have advanced at least four mutually exclusive interpretations of the “reporting requirements” concept:

1. It is, in this context, essentially nugatory and does not prohibit transfers of otherwise federally compliant funds that were never subject to federal reporting requirements in the first place, *see* MUR 5604 SOR, *supra*.
2. It may have some independent regulatory significance, but generally is not a sufficient predicate for imposing liability if the transferred funds conformed to

federal source and amount limits, *see* MUR 7123 (Jay Inslee for Washington), Factual & Legal Analysis (Feb. 14, 2018) at p. 5.⁷

3. It requires only that a non-federal entity controlled by a federal candidate register with the Commission as a political committee and disclose the origins of its cash-on-hand before using those funds in connection with a federal election, *see* Adv. Op. 2021-08 (Fitzgerald), Draft A.
4. It categorically prohibits non-federal entities controlled by federal candidates from using their funds in connection with a federal election because those monies had not been governed by federal disclosure directives at the time of their receipt, *see* Adv. Op. 2021-08 (Fitzgerald), Draft B.

In announcing in its brief that “the State Committee would have been required to disclose the donations and itemize all donations aggregating in excess of \$200 received with identification to the Commission,” OGC Br. at 10, OGC appears to be championing a construction that generally aligns with that formulated in Draft A of Advisory Opinion 2021-08. But, to employ OGC’s own logic, “[a] majority of the Commission did not approve [that] position,” OGC Br. at 13—and, in any event, this interpretive paradigm was not even proposed until more than three years after the transactions undergirding this matter.

In sum, the Respondents should not be charged with divining the contours of the “reporting requirements” element of Section 30125(e)(1)(A) when the Commission itself

⁷ To be fair, a majority of the Commission did approve the Factual & Legal Analysis in MUR 7123, but the relevant passage in that opinion consumed a perfunctory two sentences, and did not proffer an affirmative explanation of what the relevant statutory language actually means, or how (if at all) a federal candidate or EFMC’d entity could comply with the “reporting requirements” prong of the statute.

apparently remains at a loss to explain what (if anything) that phrase means, and how exactly the alleged transfer of funds to CLA supposedly transgressed it. The controlling bloc's Statement of Reasons in MUR 5604 was, at the time of the transaction in dispute, the most probative indicator of the Commission's position on this question.

While the Commission is, of course, entitled to revise or recalibrate its regulatory guidance, it cannot, consistent with guarantees of due process, impute retroactively to these Respondents an ability to foresee the future trajectory of its guidance. *See generally Christopher v. SmithKline Beecham Corp.*, 567 U.S. 142, 148 (2012) (“Where . . . an agency’s announcement of its interpretation is preceded by a very lengthy period of conspicuous inaction, the potential for unfair surprise is acute.”); MURs 6485, 6487, 6488, 6711, 6930 (W Spann LLC), Statement of Reasons of Commissioners Petersen, Hunter and Goodman (Apr. 1, 2016) at p. 2 (acknowledging that, given the “confusing” nature of past Commission pronouncements, “principles of due process, fair notice, and First Amendment clarity counsel against applying a standard to persons and entities that were not on notice of the governing norm”); *cf.* MUR 7454 (Blue Magnolia Investments, LLC), Statement of Reasons of Commissioners Dickerson, Walther, Broussard, and Weintraub (Apr. 15, 2022) (declining to impose civil penalty when “the Commission has not previously found reason to believe under these circumstances”).

CONCLUSION

For the foregoing reasons, the Commission should find that there is no probable cause to believe that the Respondents violated 52 U.S.C. § 30125(e)(1)(A), dismiss the complaint, and close the file in this matter.
