To Whom It May Concern:

I am sending this letter as a formal complaint as I believe a violation of both campaign finance disclaimers and reporting has potentially occurred.

As of today's date, a Super PAC named "Conservative Leadership for Arizona" does not appear to have timely filed a 48 Hour or 24 Hour notice with the FEC for hundreds of large road signs promoting the candidacy of Debbie Lesko in the Arizona 8th Special Election taking place on February 27, 2018. The PAC appears to have put up between 400-600 road signs over the last 21 days. A reasonable estimate for the cost of producing and installing these signs is between \$20,000 and \$25,000. The PAC has only filed one 48 Hour Notice to date, and that notice was regarding voter contact mail. It would appear the PAC has failed to file the required timely notice for the road signs.

Further, the voter contact mail piece and the road signs do not contain the required FEC disclaimer for communications not authorized by a candidate. The disclaimer is supposed to contain a street address, website, or telephone number along with other information required. Both the mail piece and the road signs are missing contact information for the PAC.

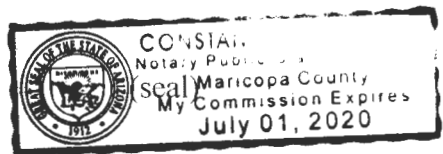
Enclosed are copies of the mail piece and the road signs showing the deficient disclaimer. Please consider this letter a formal complaint. Thank you.
