Our firm represents the Conservative Leadership for Arizona Committee and its Treasurer, Mr. Tim Sifert, in his official capacity, in connection with Matters Under Review 7344. Our Designation of Counsel form, signed by the Treasurer, is enclosed.

The Commission's notice of its reason to believe ("RTB") finding in these matters was received by the Treasurer on August 20, 2019, and it took time for the Treasurer to review them, understand their significance, and locate counsel. The Committee has no funds and is for all practical purposes defunct. It remains registered with the Commission solely due to this open matter at the Commission. The point is that in the absence of funds or staff, our client faces practical difficulties in responding
