This is an official complaint against the Dr. Richard Johnson for Congress Campaign in Texas Congressional District 18. Dr. Johnson has commenced a campaign for the United States Congress with a developed website, paid brochures, and paid campaign materials including signs and other campaign paraphernalia, but has not met the legal requirements outlined by the Federal Election Commission.

It appears that the Dr. Richard Johnson for Congress Campaign has exceeded the \$5,000.00 contribution and expenditure threshold which is in violation of 11 CFR 100.3(a)(4) and has not met the requirement to file his candidacy as required under 11 CFR 101.1 (a). This is an official complaint against the Dr. Richard Johnson Campaign for being out of compliance with the laws, rules, and regulations required by the Federal Election Commission.

We are requesting a thorough investigation into this matter based on the belief that illegal contributions and expenditures have ensued since the organization met the required threshold under 11 CFR 100.3(a)(4). Thank you for investigating this matter.





### **Phone Banking**

Phone Baking is not only an effective way of identifying current supporters and informing undecided voters, but it also allows the campaign team to gather data about voter preferences. Phone Banking requires no prior experience and is an easy way for individuals to get involved with the campaign. Volunteers simply call the provided list of voter numbers and utilize a pre-written script to communicate with constituents.

### **Block Walking (Door-to-Door Canvassing)**

Block Walking, also referred to as Door-to-Door Canvassing, is another easy way to get involved with the campaign, and requires no prior experience. This is one of the most quintessential forms of grassroots campaign activity. Block walking allows volunteers to meet constituent voters face to face. If the voter is home, the volunteers simply engage them in conversation to inform the voter about the candidate and his priorities. A conversational script will be provided. If the voter is not home, the volunteer will simply leave a door hanger or pamphlet on the voter's door.

### Media Volunteering

Media Volunteers will assist the Media Director with all of the campaign's social media accounts, including Facebook, Instagram, the Website, etc. Volunteers will help gather information to be posted electronically. They may also assist the Media Director in reaching out to press contacts, including print and media, as well as radio contacts.

Event duties will vary depending on the particular event. 


