**Re: MURs 7350, 7351 and 7382 – Request for Extension of Time**

Dear Ms. Ross and Ms. Dennis:

I write on behalf of Respondent Alexander Nix in connection with Matters Under Review (“MUR”) 7350, 7351 and 7382. Enclosed please find a Designation of Counsel form executed by Mr. Nix.

Because the complaints filed in these matters concern largely the same alleged underlying events and occurrences, Mr. Nix intends to file a consolidated response that will address the claims set forth in all three complaints, and respectfully requests that the time in which he may respond to the complaints be extended until the close of business on **Friday, July 20, 2018**.

All three complaints appear to have been sent to an address in the United Kingdom that is associated with Cambridge Analytica, of which Mr. Nix formerly was President and CEO. Because Mr. Nix’s employment at Cambridge Analytica terminated prior to the Commission’s forwarding of the complaints, however, Mr. Nix never received the complaints at that address, and indeed learned of their existence only relatively recently. The requested extension will ensure that Mr. Nix is not prejudiced by the delayed receipt of the complaints and will permit Mr. Nix and his counsel sufficient time to prepare a comprehensive and detailed response.
