I have been retained as counsel for non-parties John Bolton Super PAC and Cabell Hobbs, Treasurer ("Bolton"). A Statement of Designation of Counsel is enclosed.

Bolton first received a copy of the allegations in the Complaint on April 9, 2018. We were granted a 30-day extension until May 24, 2018. We now request an additional 30-day extension. As you know, the former principals of Bolton are now employed in high-level national security position at the White House, and we are working diligently to collect information regarding the alleged violations of federal election laws. Their schedules, however, require additional time. In addition, we have received an additional complaint concerning the same facts as those raised in this Complaint. Consequently, we respectfully request an additional extension until June 25, 2018 to respond to the Complaint.
