III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to Timely File 24-Hour Reports)

Let America Work ("the Committee") failed to timely file one (1) 24-Hour Report to support one (1) independent expenditure, totaling \$324,821.00, disclosed on the 2016 30 Day Post-General Report made after the 20th day, but more than 24 hours before the day of the 2016 General Election held in the state of Wisconsin (Attachment 2).

On November 30, 2016, the Committee filed a 24-Hour Report to support one (1) independent expenditure, totaling \$324,821.00, disseminated October 31, 2016 (Image 201611309037588212).

On December 8, 2016, the Committee filed their 2016 30 Day Post-General Report, covering the period from October 20, 2016 through November 28, 2016, which included a Schedule E (Itemized Independent Expenditures) disclosing four (4) independent expenditures totaling \$436,971.80 made in opposition of one (1) federal candidate. The Committee failed to timely file one (1) 24-Hour Report to support one (1) independent expenditure, totaling \$324,821.00, for the 2016 General Election in the state of Wisconsin (Images 201612089040051008-09).

On March 16, 2017, a Request for Additional Information (RFAI) was sent to the Committee referencing the 2016 30 Day Post-General Report. The RFAI noted the Committee may have failed to timely file one or more of the required 24-Hour Reports regarding independent expenditures. A chart was included with the RFAI identifying one (1) independent expenditure, totaling \$324,821.00, for which a 24-Hour Report had not been timely filed (Image 201703160300082794-96).

On March 21, 2017, Benjamin Ottenhoff, the Committee's Treasurer, called the Reports Analysis Division (RAD) Analyst to note that he had received the RFAI and to ask whether a response was required. Mr. Ottenhoff noted that the Committee was already aware of the issue and had filed a *sua sponte* submission with the Office of General Counsel (OGC). Mr. Ottenhoff asked whether any further response was required, and whether failure to respond would incur additional penalties. The Analyst informed him that the Committee could either submit a letter explaining that the Committee would not be taking any action with regards to the RFAI, or the Committee could simply let the response window close. Mr. Ottenhoff informed the Analyst that the Committee would likely not send a response and would instead let the response window close (Attachment 3).

On April 28, 2017, the RAD Analyst spoke with Mr. Ottenhoff and let him know that the issue addressed in the RFAI referencing the 2016 30 Day Post-General will be referred to another office for additional enforcement and advised him to file a Miscellaneous Electronic Submission ("FEC Form 99") if he has any additional information to add to the public record. Mr. Ottenhoff stated that the Committee would likely not file an FEC Form 99 (Attachment 3).

To date, no further communications have been received from the Committee regarding this matter.
