Sir:

I am hereby writing a complaint against the Hughes for Congress Campaign in regarding the following issues:

1. Falsifying the FEC Form 3 for the quarter ended March 31, 2018 by David Hughes. The operating expenses line 7a is understated. Cash on Hand at closing (line 27) is overstated. The operating expenses did not include operating expenses from February and March 2018 are not shown on FEC Form 3. The cash on hand at closing is overstated by approximately \$20,000. The United Valley Bank shows disbursements of \$27,965.52 from January 2 through March 20, 2018. The FEC Form 3 shows \$9,562.89 for the quarter from January 1 through March 31, 2018. I have a copy of the bank statement through March 20th, 2018.

Dave Hughes has been completing FEC Form 3 since 2016. This gives me reason to believe he deliberately did not include the disbursements for February and March 2018 to increase his Cash on Hand for the campaign. It appears deceitful.

2. I started working with Dave Hughes for Congress in October 1, 2017 as a volunteer. I was asked to do a detailed analysis of 2016 - 2017 contributions. I used the Hughes for Congress bank account and FEC Form 3 in order to reconcile the bank statement. I put financial procedures in place for the 4th quarter. A spreadsheet that had information to apply a fundraising protocol. Procedures only work if you follow them. David Hughes was working with a fundraiser and needed an accounting.

The end of 4th quarter, I put the information from the bank statement into the FEC Form 3. There were no receipts, mileage logs and David had to complete it. David asked me to sign the 4th quarter report. I told him I would not sign it.

I called the FEC because there was approximately \$20,000 missing from the 1st quarter report that David had filed. In the pages that the FEC had questions about, they had included letters with my name as Treasurer on it. The FEC told me to file a complaint. And to send a copy of my resignation.

I have never seen a check book, did not make deposits, had no authority to authorize payments or contracts with vendors. David Hughes sent the FEC Form designating me as Treasurer on December 27, 2017. I was informed of this on January 27, 2018. I have never signed my name to a form to be Treasurer, nor have I electronically filed FEC Form 3. I have never signed anything as Treasurer of the Hughes for Congress Campaign. David needed to work the protocol and be able to move it to an independent Treasurer for his campaign.

On April 21, 2018, I printed a request to amend a report and was upset to see my name as Treasurer for Hughes for Congress on a letter dated, April 10, 2018. The letter requesting me to amend a 4th quarter report regarding contributor information, excess contributions that I talked to Dave about before he submitted it. The request to amend this report was due by April 15, 2018

3. David Hughes took out a loan for \$40,000 on June 22, 2017 in order to "jump start the campaign." David Hughes has never provided me a copy of the loan starting in August 2017. David Hughes has written himself checks for various amounts. The amounts he paid to himself continually increased overtime. According to David Hughes, the note is payable in monthly payments of \$851.70 per month, payable to the Service Credit Union. A list of payments is attached.

The campaign had difficulty purchasing stamps, was unable to fund a small phone bank and was not able to pay its vendors in a timely manner. The funds were paid to David Hughes personally. Lack of funds was a critical problem for the campaign.

4. David Hughes did not keep a mileage log that I have seen. I have asked him several times to provide a log of where he traveled, and meetings he had with contributors. It appears that David fills up his car with gas and charged it to the campaign. David works in North Dakota and drives many miles to work from Karlstad, MN. It is not clear what is lodging, food and gas for the family and what is for the campaign.

David Hughes thinks and has stated that "Point of Sale" are a substitute for an actual receipt. He has told this to his fundraiser and many people. He needs to understand and accept the protocol of a receipt for the people that are working for him. David Hughes wrote a check to Dahlstrom Motors on February 13, 2018 for \$668.42 and charged it to the campaign. This is not mileage.

Dave Hughes and I have met face to face once on February 11, 2018. I drove three hours and stayed in a motel for two days before he came. He had 2 1/2 hours to talk about the procedures. I believe Dave understands what he is doing. David has had several opportunities to meet but has not made it a priority. The ability to be trusted with money, and accurate with your reporting is essential for public officials.

A qualified multi-candidate committee and all affiliated committees may not make a contribution(s) to a candidate for federal

The term "contribution" includes any gift, subscription, loan, advance, or deposit of money or anything of value made by any person for the purpose of influencing any election for federal office. (52 U.S.C. § 30116(a) and (f) (formerly 2 U.S.C. § 441a(a) and (f)); 11 CFR §§ 110.1(b), (e) and (k), and 102.13(c))

If any apparently excessive contribution in question was incompletely or incorrectly disclosed, you must amend your original report with clarifying information.

Please be reminded that all refunds, redesignations and reattributions must be made within 60 days of receipt of the contribution. To date, one or more of the apparent excessive contributions have not been refunded, redesignated, or reattributed.

For reattributions, the funds can be retained if, within 60 days of receipt, the excessive amount was properly reattributed to another person. An excessive contribution is considered properly reattributed if (1) the contributors provide the committee with written documentation, signed by each contributor, authorizing a reattribution and indicating the amount of the contribution to be attributed to each contributor; or (2) the committee reattributes by presumption the excessive portion of the contribution if the contribution was made on a written instrument from a joint account and was signed by only one of the account holders. 

** Hughes response*

Mike, I'm unsure what you mean by reconciliation. I've attached four .pdf bank statements that cover the period: I hope this helps. My methodology, as I recall, was to count contributions within the FEC reporting period if the check or paypay contribution was dated in that period, even if it wasn't in the checking account by the end of the quarter. Likewise, I reported disbursements in each quarter based on when they showed up in the checking statement, not necessarily according to the vendor's transaction date. It usually worked out, but there might have been some cases where I bought something on, say, 9/28/17, but it didn't show up in the bank statement until the following FEC reporting quarter. I don't know of any specific cases, but this might have happened.

I wanted to review the discussion we had on February 20, 2018 and reach a understanding for both of us.

1. We talked about the FEC report that is due for the period from October 1 through December 31, 2017 and how to do the report. We discussed the loan the unsecured loan you initiated on 6-9-2017 and reported on the FEC report as a personal loan as of 6-30-2017. The loan was initiated from Service Credit Union for \$40,000, payments in the amount of \$851.70 per month at 9.9% interest for 60 months ending in 6-9-2022. We discussed the fact that you listed it as a personal loan rather than a loan from a lending institution. I thought the loan should have been listed as a loan from Service Credit Union rather from you personally. The payments could have been made directly to the credit union and the interest expense listed as an expense as the payments were made. If the payments were made to the credit union the FEC report would show payments being made to the credit union rather than being made to you personally. It would give a different appearance on the FEC report.
2. We talked about the fact that you were doing the FEC reports and did have receipts for the expenses , lodging, restaurants, and recurring expenses for campaign operating expenses. We talked about the transportation issue. You stated that you could prove what the gas was used for and where you went. I stated to you that you are required to keep a mileage log and should be charging mileage at the federal transportation rate rather than just fill the automobile tank and charging the campaign for gas at unspecified times. We talked about the meals and restaurant meals. The meals needed to be documented as to who you were with, the date, meeting place and a receipt for what you purchased. When, where, why and amount spent. We talked about the lodging expenses. Again, when and where and why the lodging was

needed and for what event and who was with you at the time . We discussed categorizing the expenses and describing what the expenses were for and when the supplies were used. The expenses need some description as what the expenses were used for. We talked about all of the (pos) point of purchases receipts and that they have a detailed description. We talked about establishing a budget for spending so the campaign would have an idea what to spend and what the expected income from contributions were expected to be in the future.

3. We discussed running the campaign on a business basis and recording receipts and disbursements on a organized basis. We discussed having the bank register the treasurer as a signer on the bank account. We talked about bank card, if available , so the volunteers could have a method to purchase stamps, envelopes and necessary mailing supplies. We discussed policy and steps to run the campaign when there were more people involved in the campaign.

W discussed these things and more regarding the campaign and the structure of a business and the need to account for the spending and public contributions given to the campaign.

The loan is a unsecured loan to be paid in monthly payments of \$851.70 per month, a 60 month loan ending in 6-9-2022. The FEC reports are available to public scrutiny and anyone who want to see what a candidate is doing with his money can browse through the information that has been schedules. If the campaign wants to show more contributions are coming into the campaign, maybe you should have donated the \$40,000 of the loan as a contribution by David Hughes. Anyone looking at the FEC report as it currently stands my get the opinion that the current contributions to the campaign are really going to retire the debt. They may ask themselves "why should we contribute money to a campaign that will all go to debt repayment". People like to know that their contributions are going for a cause, not just retire out of control spending. That is what is happening now in congress.

People do not want to cause to contribute to, such as boarder security, liberty, equal rights, jobs, or retiring the national debt to have an impact on our living standard. The campaign would have been better off doing what Wellstone did and purchase a old bus and campaign around the state. Maybe we should rent a RV and tour the 7th district and get our message out to the people.

I am concerned that we need to correct our reporting and as an example, show people what a campaign really stand for. Someone from Washington D C will look at the reports filed and state " the candidate is paying himself more than his Campaign staff". The campaign looks like it is "shady".

If the FEC investigates the campaign, I want the campaign to be able to substantiate the spending of public campaign funds. That means receipts, substantiation of expenses, no questionable expenditure, no questions of travel expenses, lodging expenses, or food expenses for meetings. The campaign needs to fess up and correct its problems. The number one untrustworthy professional in the United States is any one in congress. They are even worse than the used car salesman who leaves you with a pile of junk and takes your cash.

We need to prove we are better. Establish a budget, be honest with the people, the truth about our current international situation, tell the truth about where our money is being spent. Everyone needs and hopes for a better standard of living. We all expect to work for that better standard of living.

Dave, I do not want it to appear that you are taking money from the campaign in order to make your payments at home. Other people can see you drawing money out of the campaign and wonder "is he paying himself"? Where is the money going? Does he need money to make his household bills? Are the payments to himself really going to retire the debt? One way would be to show people what the remaining debt to Service Credit Union really is at this date. We just want you to not be like what "people think" their other congressmen are. I am also concerned if you are using the money personally, how will you pay the balance to the Service Credit Union if the campaign ends and you owe the loan for four more years. We do not want you paying personally for campaign debts.
