A COMPLAINT

Regarding prohibited contributions by Scott Sayre and Sayre Enterprises. With copy to the Department of Defense Inspector General and the GSA Office of the Inspector General.

- This complaint alleges violations of the Federal Election Campaign Act of
 and other applicable law by R. Scott Sayre, and his company, Sayre Enterprises,
 involving Cynthia N. Dunbar, a candidate for the United States House of Representatives,
 and the 6th Congressional District Republican Federal Committee.
- 2. Upon information and belief, Scott Sayre and Sayre Enterprises appear to have made illegal, doubly source-prohibited contributions to House candidate Cynthia Dunbar and the 6th Congressional District Republican Federal Committee, a federal political committee of which Sayre currently serves as Chairman. Federal law prohibits contributions to federal candidates and political committees from corporations and federal contractors. Federal law and regulation provide for sanction and, in extreme cases, debarment of a federal contractor, where violations have occurred.

Complaint Against R. Scott Sayre, Sayre Enterprises, Cynthia N. Dunbar, and the 6 Congressional District Republican Federal Committee

BACKGROUND - PARTIES

- 3. Respondent Scott Sayre currently serves as Chairman of the Sixth District Republican Committee, existing as a distinct organizational unit within the Republican Party of Virginia. As Chairman, Sayre is responsible for overseeing the activities of the committee, its members, and vendors which provide it with services. Sayre is running for reelection as Chairman at a nominating convention scheduled for May 19th, 2018. Sayre maintains his residence at Lexington, VA 24450.
- 4. Respondent Sayre Enterprises is a corporation existing under the laws of the Commonwealth of Virginia with its principal physical place of business located at 45 Natural Bridge School Road, Natural Bridge Station, VA 24579. Scott Sayre and his wife, Mary, are both listed as officers in records maintained by the Commonwealth of Virginia. While the exact ownership structure is unknown, Scott is believed to own some or all of the corporation, either individually, or with his wife, Mary.
- 5. Respondent Cynthia N. Dunbar is currently one of eight filed and declared candidates seeking the Republican Party's nomination for the United States House of Representatives in Virginia's Sixth Congressional District, to be decided at a nominating convention scheduled for May 19th, 2018. Dunbar maintains her campaign committee's reporting address at P.O. Box 2238, Forest, VA 24551.
- 6. Respondent 6th Congressional District Republican Federal Committee is a federal political committee, not authorized by any candidate, which serves as the principal vehicle for receipt and expenditure of funds by Republicans in connection with federal elections in Virginia's Sixth Congressional District. The committee maintains its reporting address at 1063 Coronado Lane, Lynchburg, VA 24502.

COMPLAINT ONE:

SOURCE-PROHIBITED CONTRIBUTION TO FEDERAL COMMITTEE

- 7. Sayre Enterprises derives a substantial portion of its revenue from federal contracts. According to USASpending.gov, Sayre Enterprises has received 912 prime awards through the Department of Defense and the General Services Administration worth \$14,525,745.95¹. Sayre Enterprises manufactures insignia, tactical equipment, and other similar items and is heavily reliant on federal spending for its revenue.
- 8. In a statement to the Richmond Times-Dispatch² published April 25th, 2018, Scott Sayre acknowledged that Sayre Enterprises made an in-kind contribution of office space for a "headquarters" to the Sixth Congressional District Republican Federal Committee, of which he currently serves as Chairman, writing, "All political discussions or meetings if they took place would have been conducted in the 6th District headquarters and conference rooms located in the same building where Sayre Enterprises is headquartered. The conference room at issue is open to and used by all district committee members. Both Tederick and Dunbar are committee members."
- 9. Under the direction of Scott Sayre, the headquarters at Sayre Enterprises was also used to formally hear challenges to delegates for the May 19th federal nominating convention, according to an email from a committee member overseeing the process on behalf of Sayre³. This constitutes the formalization of Sayre Enterprises as a place for

Scott Sayre to oversee and direct the business of the committee as it meets with political leaders and voters who are not employees, stockholders, or members.

- 10. The Sixth District Republican nominating convention is organized according to an official call⁴ issued by Chairman Scott Sayre. In the call, he lists the address of Sayre Enterprises as the location of the Sixth District Committee's headquarters and specifies it as the location to which all convention-related mail is to be sent in accordance with the call. Presumably, employees of Sayre Enterprises would separate the political mail from the business mail, constituting an in-kind contribution of administrative personnel from Sayre Enterprises to the Sixth District Committee.
- 11. The committee routinely uses its headquarters on the premises of Sayre Enterprises to conduct its meetings. This includes, for example, the quarterly meeting at which the 2018 Sixth District federal nominating convention was formally called, as evidenced by the attached meeting minutes.
- 12. According to federal⁵ and state⁶ campaign finance records, the 6th Congressional District Republican Federal Committee has never compensated Sayre Enterprises for the use of its corporate office space nor for the use of its administrative personnel. Neither account reports any payments to Sayre Enterprises at any time, for any purpose.
- 13. Under federal law, the use of a corporation's facilities in connection with a federal election by a person other than an employee, stockholder, or member requires that the user reimburse the organization within a commercially reasonable time and at the usual and normal charge.

- 14. Under federal law, meeting rooms are treated the same as other facilities unless the corporation customarily makes its meeting rooms available to clubs, civic organizations, and other groups. It does not appear that Sayre Enterprises makes its corporate headquarters available for use by non-political entities.
- 15. Except for a several-month period in 2017 when Dunbar received compensation in excess of \$5000 from Sayre Enterprises⁷, no other members of the Sixth District Committee appear to be employees, stockholders, or members of Sayre Enterprises subject to the exception on the use of meeting space and facilities.
- 16. Consequently, Scott Sayre's on-the-record acknowledgement that Sayre Enterprises gave space to the committee for an ongoing "6th District headquarters and conference rooms located in the same building where Sayre Enterprises is headquartered" for use by "all district committee members" including those who are not employees, stockholders, or members of Sayre Enterprises appears to constitute an illegal in-kind contribution of office space, utilities, and other facilities expenses to a federal political committee.
- 17. Furthermore, the provision of this space to Dunbar's campaign for planning purposes, and not her seven competitors, appears to constitute an illegal in-kind contribution of office space to a candidate for federal offices.
- 18. Contributions from Sayre Enterprises to federal political committees or federal candidates are doubly source-prohibited, as Sayre Enterprises is both a corporation and a federal contractor.
- 19. Federal contractors face potential debarment for violations of federal law, including prohibitions against corporations and federal contactors making contributions, either on a cash or in-kind basis, to federal political committees and federal candidates.

20. The committee's receipt of an in-kind contribution of office space for its "headquarters" – as located within the headquarters of Sayre Enterprises – raises the possibility that a corporation with substantial federal contracts is exerting undue influence over the political process through its doubly source-prohibited contribution, which competitors are prohibited from making pursuant to federal law and regulation.

COMPLAINT TWO:

SOURCE-PROHIBITED CONTRIBUTION TO FEDERAL CANDIDATE

- 21. According to a financial disclosure statement⁸ filed by Cynthia Dunbar with the Clerk of the House of Representatives in connection with her campaign, Dunbar was paid in excess of \$5000 by Sayre Enterprises in 2017 for "research and development." Filing requirements do not mandate disclosure of the exact amount. In public comment, Dunbar has refused to detail the exact amount she received from Sayre Enterprises and has additionally refused to detail the specific nature of the work performed.
- 22. By training and profession, Dunbar is a constitutional law attorney and former constitutional law professor whose professional resume shows no indication of subject matter expertise in "research and development" related to the kinds of products manufactured by Sayre Enterprises, or in the marketing thereof⁹.
- 23. According to emails released publicly and attached to this complaint, a proposal for Dunbar's congressional campaign was sent from a political consultant to

Scott Sayre on May 2nd, 2017. On May 10th, 2017, Sayre responded to the consultant, writing, "Can you and the team consider this proposal for [Dunbar's] campaign?"

- 24. According to FEC Advisory Opinion 2015-09, an individual becomes a federal candidate "when he or she makes a private determination that he or she will run for federal office."
- 25. Therefore, Cynthia Dunbar was a federal candidate according to federal law no later May 10th, 2017.
- 26. Under federal law, Dunbar's receipt of funds from Sayre Enterprises would constitute a doubly source-prohibited contribution unless the payment resulted from bona fide employment genuinely independent of the candidacy and be exclusively made in consideration for services performed by the employee.
- 27. Considering Dunbar's lack of skills relevant to the "research and development" performed by Sayre Enterprises, it appears unlikely that Sayre's payment meets the requirement for bona fide employment independent of her candidacy.
- 28. Dunbar reported only \$15,700 in earned income and limited liquid assets on her personal financial disclosure¹⁰, along with high amounts of personal debts, suggesting that she may not have been financially able to be the ultimate source of the \$32,597.02 she had loaned to her campaign as of its pre-convention report as filed with the FEC on May 7th, 2018¹¹. Additionally, the campaign owes her another \$6925.91 in incurred debts.
- 29. Dunbar's potential receipt of a doubly source-prohibited corporate contribution from Sayre Enterprises raises the possibility that a corporation with substantial federal contracts is exerting undue influence over the political process through favoritism shown to a candidate for the United States House of Representatives, who, if elected, could directly influence business matters regarding Sayre Enterprises.

30. This contribution, if proven, would be one of many acts of favoritism shown by Scott Sayre to the campaign of Cynthia Dunbar, which he has publicly supported, to a great deal of controversy from other candidates and their supporters throughout the entire nomination cycle.

REQUEST FOR INVESTIGATION AND RELIEF

31. Complainant requests the Federal Election Commission expeditiously investigate both of the foregoing complaints and take all appropriate actions within its authority to restrain future violations of the law by R. Scott Sayre, Sayre Enterprises, Cynthia N. Dunbar, and the 6th Congressional District Republican Federal Committee.



The motion to hold the Convention at the JMU Convocation Center passed.

Vice Chairman Matt Tederick moved that the date of the convention be May 19, 2018. The motion was seconded. The motion carried.

Vice Chairman Matt Tederick moved that on .Line 74 of the Draft Call, add the words "for delegate to the

Sixth District Convention" so that it reads, "No unit pre-filing deadline for delegate to the Sixth District Convention shall be earlier than February 17, 2018. Nate Boyer seconded the motion. The motion carried.

Ken Adams moved an amendment to keep the February 23rd date where it was and to change the end date to March 30th The motion passed.

The main motion with the Amendment of line 74 with a starting date of 23 February and an ending date of 30 March was voted on. The motion passed.

Vice Chairman Matt Tederick moved to add on Line 158

E. Delegate Voluntary Registration Contribution

A voluntary contribution of \$20.00 is requested of each Delegate and Alternate Delegate to the District Convention to help defray the cost of the Convention. Unit Chairs are requested to collect and transmit all registration contributions and spreadsheet of all Delegates and Alternate Delegates and their contribution to the District Treasurer, Hud McWilliams, P.O. Box 621, Daleville, VA 24083.

There was a second to the motion. The motion passed.

Gene Rose moved on line 163 that the email should be removed as a mandatory requirement. Cher McCoy gave a second.

Mike Troxel moved for an Amendment which dealt with the changes to Line 162 to add prior to the word phone (and as optional phone numbers and email addresses.) The motion failed.

The Committee moved to Gene Rose's motion. The motion was to edit line 163 by deleting four words (and as applicable email addresses.) Carrie Thompson stated that on line 163 rather than the words (as applicable) to change it to (if provided) and on line 166 to add (Units are required to submit all information provided on Pre Filing forms). A second was given. The motion carried.

The Committee voted on Gene Rose's amended motion. The motion carried. Phone and email would not be required, but if submitted must be included on the filing form.

Vice Chairman Matt Tederick moved on Line 81, add the following: **F. The vote was 10 yes and 18 no, with two members abstaining. The motion failed.

A motion and second was made to adopt the Call as amended. The motion carried.

The CRs reported that they looked forward to helping the Congressional nominee get elected.

Announcements: The Chairman stated that the Committee would conduct four Congressional Forums over the next several weeks.

The next District meeting was set to be held on April 7th.

Two of the Congressional candidates, Ed Justo and Kathryn Lewis, spoke next,.

The Chairman thanked Steve Richards for the great job that he did as Sergeant At Arms. He also thanked Stuart Bain for being the Parliamentarian.

A motion with a second was made to adjourn. The motion carried.
