
The Federal Election Commission has the statutory duty of enforcing the Federal Election Campaign Act of 1971, as amended, and Chapters 95 and 96 of Title 26, United States Code. Currently before the Commission is a matter in which it appears that you may be able to provide relevant information. As such, the Commission requests that you provide a written submission that responds to the following questions, and provide all the documents requested in connection with your responses. You are not the subject of the Commission's investigation and the Commission does not consider you a respondent in this matter, but rather a witness only.

Under federal law, all persons are required to keep confidential investigations conducted by the Commission, except with the written consent of the subject of the investigation.

*See 52 U.S.C. § 30109(a)(12).* This means that unless you have such written consent, you should not publicly disclose the existence of an ongoing Commission investigation or the fact that the Commission has contacted you in connection with this matter. This restriction, however, does not prevent you from discussing the underlying facts and circumstances with any person, including the subject of the investigation or their counsel.

You may consult with an attorney and have an attorney assist you in the preparation of your response. However, we request that you submit the information by December 6, 2019. If you have any questions, please contact me (202) 694-1628, or by email at nbamman@fec.gov.
