As such, the Commission requests that you provide a written submission that responds to the following questions, and provide all the documents requested in connection with your responses.


Under federal law, all persons are required to keep confidential investigations conducted by the Commission, except with the written consent of the subject of the investigation. *See* 52 U.S.C. § 30109(a)(12). This means that unless you have such written consent, you should not publicly disclose the existence of an ongoing Commission investigation or the fact that the Commission has contacted you in connection with this matter. This restriction, however, does not prevent you from discussing the underlying facts and circumstances with any person, including the subject of the investigation or their counsel.

Please note that you have a legal obligation to preserve all documents, records and materials relating to this matter until such time as you are notified that the Commission has closed its file in this matter. *See* 18 U.S.C. § 1519.
