I will be designated counsel for the subject matter, and the FEC counsel designation form is currently under preparation by AFT staff. I expect it will be submitted to your office either today or Friday, April 6.

In advance anticipation of my official designation, I hereby request an extension of time to respond to the matter until May 4, 2018. I hope you can put this request in a pending status until the form is received from AFT. If you cannot do so, please advise and I will resubmit this e-mail at a later date.

The extension to May 4 is needed because an adequate response will require research into the financial transactions at issue and that will involve obtaining input from several AFT staff and management. Those personnel will also need to review any draft submission that I prepare. In addition, my necessary prep time for this matter also falls within the same time frame when I will be completing my personal federal and state income tax filings. I also note that May 4 is 30 days after I received notice from my primary AFT contact that the subject letter had been received by AFT. Thus, an extension to May 4 is not unreasonable, given the above circumstances.
