





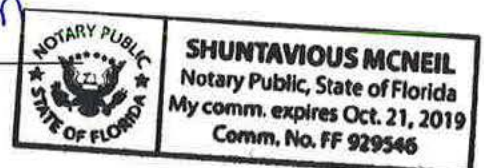

RE: Apparent Violation of § 30102, 30103, and 30104 of the Federal Election Campaign Laws

To Whom It May Concern;

A Political Action Committee, identified as "Fair People for Fair Government," has been distributing misinformation about Mr. Dave Cummings and Mr. Brian Mast; who are both Congressional Candidates for the US House of Representatives seat in Florida District 18.

A review of Federal Election Commission and Florida Department of State Records (attached) determined that "Fair People for Fair Government" is not registered as a Political Committee on either the State or Federal Level. I believe the actions of the entity known as "Fair People for Fair Government" to be in violation of § 30102, 30103, and 30104 of the Federal Election Campaign Laws; which require political committees to designate a campaign treasurer and a primary depository, to file a statement of organization no later than 10 days after designation, and to file receipts of disbursements. A political committee which fails to identify a treasurer or depository is subverting the process of transparency in its donors, expenditures, and motives; and is subverting the processes of our Constitutional Republic.

It is my belief that Ms. Ali Schmitz of Treasure Coast Newspapers may have additional information related to "Fair People for Fair Government" as she alluded in her article on July 13, 2018 (<https://www.tcpalm.com/story/news/politics/elections/2018/07/13/illegal-mailer-attacks-dave-cummings/766331002/>) that, "TCPalm is awaiting a response to its public-records request to the Post Office to determine the origin of the mailer."
