This requests an extension of time to respond to the letter from the Federal Election Commission informing our client, Fighting for Ohio Fund and Christopher M. Marston in his official capacity as Treasurer, of a complaint filed against them in the above-referenced matter. Although the Commission's letter is dated August 13, 2018, Respondents did not receive the letter until October 10, 2018. It appears that the original letter was sent to the wrong address.
