24 **I. INTRODUCTION**

25 On September 20, 2021, the Office of General Counsel ("OGC") notified counsel for
26 Freedom Vote, Inc., ("Freedom Vote" or "Respondent") that it was prepared to recommend that
27 the Commission find probable cause to believe that Freedom Vote violated 52 U.S.C. §§ 30102,
28 30103, and 30104(a), (b), and (g)(2) by failing to organize, register, and report as a political
29 committee.¹ OGC's notification included a General's Counsel's Brief setting forth the factual
30 and legal basis for the recommendation.² Respondent submitted a Reply Brief on October 5,
31 2021.³

1 Pursuant to the *Agency Procedure Following the Submission of Probable Cause Briefs by*
2 *the Office of General Counsel*, 76 Fed. Reg. 63,570 (Oct. 13, 2011), OGC is hereby notifying the
3 Commission that it intends to proceed with the recommendation to find probable cause to believe
4 that Freedom Vote violated the Federal Election Campaign Act of 1971, as amended, based on
5 the factual and legal analysis set forth in the General Counsel's Brief. A copy of this Notice is
6 being provided to the Respondent at the same time that it is circulated to the Commission.

7
8 For the reasons set forth in the General Counsel's Brief, the Commission should proceed
9 with finding probable cause to believe that Freedom Vote failed to organize, register, and report
10 as a political committee.

12 **II. RECOMMENDATION:**

13
14 Find probable cause to believe that Freedom Vote violated 52 U.S.C. §§ 30102,
15 30103, and 30104(a), (b), and (g)(2) by failing to organize, register, and report as
16 a political committee.
