Dear Ms. Ross:

I am writing in response to FEC complaint MUR 7487 that I received on September 5, 2018. I have attached documentation to show that no violation has occurred and will further explain below.

My first campaign contribution to Senator Donnelly on 3/25/17 was made by check and submitted in a donation envelope. This donation is listed with my correct employment information, Courtney Tritch Consulting, on the FEC website. The next contribution I made was also to Donnelly on 4/27/17 and was made electronically. For some reason, Act Blue has listed me as unemployed and I do not know how that change occurred.

I have made multiple small contributions to multiple campaigns between that time and the present. I am including all of my Act Blue receipts that all show that I have listed my correct employment information (with the exception of the one Donnelly receipt where there seems to have been an error). It appears that somehow between the Act Blue site and the FEC reports, the information got changed. Additionally, my most recent receipt to UltraViolet PAC on 7/26/18 shows my correct employment information on both the Act Blue receipt and the FEC website.

This leads me to believe that perhaps there was a glitch with Act Blue that resulted in my information being changed between the Act Blue receipts I have and the FEC website. During this time period, I have always listed my employment as Courtney Tritch Consulting and my Act Blue profile and the accompanying receipts illustrate that.

Additionally, I am not sure how the FEC Complaint letter came to be addressed to my old employer, but please note for the future that my correct mailing address is 1017 Maxine Drive, Fort Wayne, IN 46807.

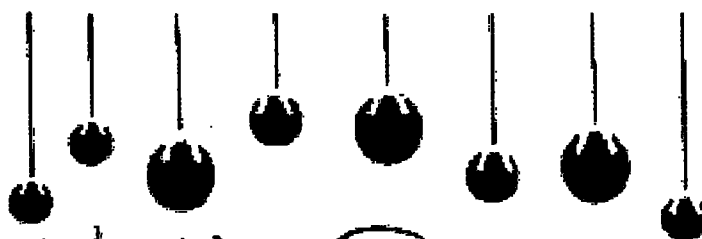
