RE: MUR 7512 - Complaint – Election Contributions by foreign nationals

Dear Ms. Ross:

This is in response to a letter dated October 19, which I received from Jeff S. Jordan, Assistant General Counsel, confirming receipt of my complaint of October 12 regarding the above matter. Mr. Jordan's letter asked me to forward any additional information I might receive, so this is the purpose of the present letter.

Since I assume that the foreign nature of the entity making the election contributions is key to the FEC's pursuit of this matter, I'm attaching several additional documents confirming that Jordan Cove LNG is a foreign entity, and others that contain additional information about their campaign contributions.

Attachment 1 to this letter is a bundle of 6 documents (most printed double-sided) from the Oregon Secretary of State's Corporation Division, regarding the corporate status of Jordan Cove. As the first of these document shows, quite a few corporate entities go by the name "Jordan Cove", but with slightly different corporate natures, like L.L.C., L.P., etcetera. But as the bundle's other documents show, all describe themselves as "foreign".

Attachment 2 is an updated list of campaign contributions by Jordan Cove LNG which shows, among other things, that Jordan Cove's contributions to John Sweet's re-election campaign have risen to a total of \$50,000. But Jordan Cove has also contributed to other campaigns and to entities that could serve as pass-through campaign contributors, like the ChamberPAC.

Attachment 3 is a list of both contributions to and expenditures by ChamberPAC, which makes it a little confusing to read. It shows 2 contributions by Jordan Cove to ChamberPAC totaling \$70,000, which ChamberPAC has passed on to various candidates, although of course the exact destination of these funds might be difficult to determine, since Jordan Cove was not the only contributor to ChamberPac, although it was the

largest one by far. Hence we cannot doubt that most of the \$25,000 that ChamberPAC gave to candidate for state governor Knute Buehler came from Jordan Cove. His opponent, incumbent governor Brown, has been more or less neutral on Jordan Cove, and – perhaps unsurprisingly – her name does not appear on ChamberPAC's list.

In the meantime Jordan Cove has been promoting itself with self-congratulatory media messages. It cannot be a coincidence that their publicity efforts have gone into high gear just before the election; I have also noticed that on one radio station, KWRO, commercials touting the goodness and benefits of Jordan Cove have immediately followed campaign commercials for John Sweet.

Whether this is planned and deliberate I don't know, but I have no doubt that, at least in part, this is another move by Jordan Cove to improve Sweet's chances of getting re-elected, because he has come under some fire lately for his pro-Jordan Cove stance and for Jordan Cove's contributions to his campaign.

Attachment 4 reproduces one of the Jordan Cove mailers, reduced from its original size.

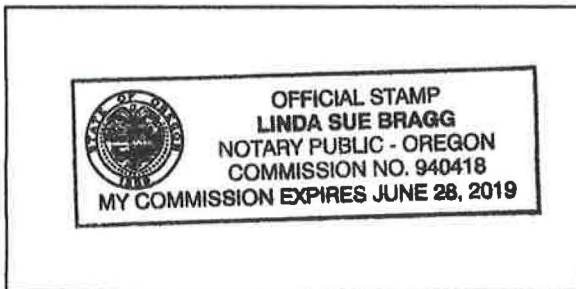
