To whom it may concern,

I am writing in response to complaint filed against Peter Courtney for State Senate, complaint number MUR 7512. I am the campaign manager for Peter Courtney for State Senate, and have been authorized to respond to this complaint by Senator Courtney. The envelope with the complaint was postmarked November 14th, 2018. We are responding within the 15 days given in the letter.

We believe that no action should be taken against Peter Courtney for State Senate in this matter. Though Courtney's PAC isn't specifically mentioned in the complaint, I assume we were included because of a \$5,000 contribution from Jordan Cove Enervendor Pm on 8/17/2018. As you can see on Orestar (screenshot attached), Jordan Cove Enervendor Pm, as with the other Jordan Cove entities, has an office in Portland, which is where the check was issued form.

More importantly, as seen in the attached letter, Jordan Cove's contributions to PACs in Oregon come from funds generated by US assets. "In compliance with federal and Oregon laws, these funds will come from revenue generated by Pembina's US assets that stay in the US and are transferred to Jordan Cove to support the project's development activities. Jordan Cove Energy Project LP is a US company registered in Delaware."

The attached letter is addressed to The Senate Democrat Leadership Fund, the PAC for the Oregon Senate Democrats caucus, but the letter applies to funds given to Senator Courtney's PAC as well.

We accepted this contribution with the understanding that Jordan Cove was in full compliance with Oregon and Federal law, and reported the contribution in line with Oregon's campaign finance laws.

Please let me know as soon as possible if any further action will be taken against Peter Courtney for State Senate, as we would then likely designate counsel on our behalf.
