Dear Ms. Ross:

This firm represents Carol A. Russell in her capacity as Treasurer for the following committees: Friends of David Brock Smith, Friends of Duane Stark, Friends of Gary Leif, Friends of Tim Freeman, Friends of Dallas Heard, and Knute for Governor. We also represent Malinda F. Wilson in her capacity as Treasurer for Citizens to Elect Carl Wilson. Please see the attached statements of designation of counsel.

First, Knute for Governor never received any contribution from Jordan Cove Energy Project LP ("Jordan Cove"). Indeed, the Oregon Secretary of State's database shows no contribution from Jordan Cove to Knute for Governor. Further, Jordan Cove's legal counsel has represented to us that neither Jordan Cove nor any of its affiliates gave any contribution to Knute for Governor. Consequently, no action should be taken against Knute for Governor.

As to the other committees, yes, Jordan Cove made contributions to them. Jordan Cove has represented that the funds for its political contributions are generated in the United States, stay in the United States, are made from a United States domestic company, are drawn from Jordan Cove's United States bank account, and that all decisions regarding Jordan Cove contributions are made by United States citizens (please see the attached letters from Charles Deister, Jordan Cove's manager for government relations, and attached annual report for Jordan Cove). Each of the committees relied and rely upon Jordan Cove's representations in accepting the contributions. In light of the above facts, no action should be taken against Friends of David Brock Smith, Friends of Duane Stark, Friends of Gary Leif, Friends of Tim Freeman, Friends of Dallas Heard, or Citizens to Elect Carl Wilson.
