A copy of an image of a yard sign taken at the corner of Truelove Road and HWY 129 North in Cleveland, Georgia is attached as well as a recent advertisement from The Northeast Georgia Shopper dated September 19 to October 10, 2018. Joshua Braxton McCall (FEC candidate ID H8GA09058) is a Democratic Party candidate for Representative in the Georgia 9th Congressional District. Failure to include the required "Paid for" disclosure on materials distributed to the public is a violation of 11 CFR 110.11 and 2 USC 441(d).

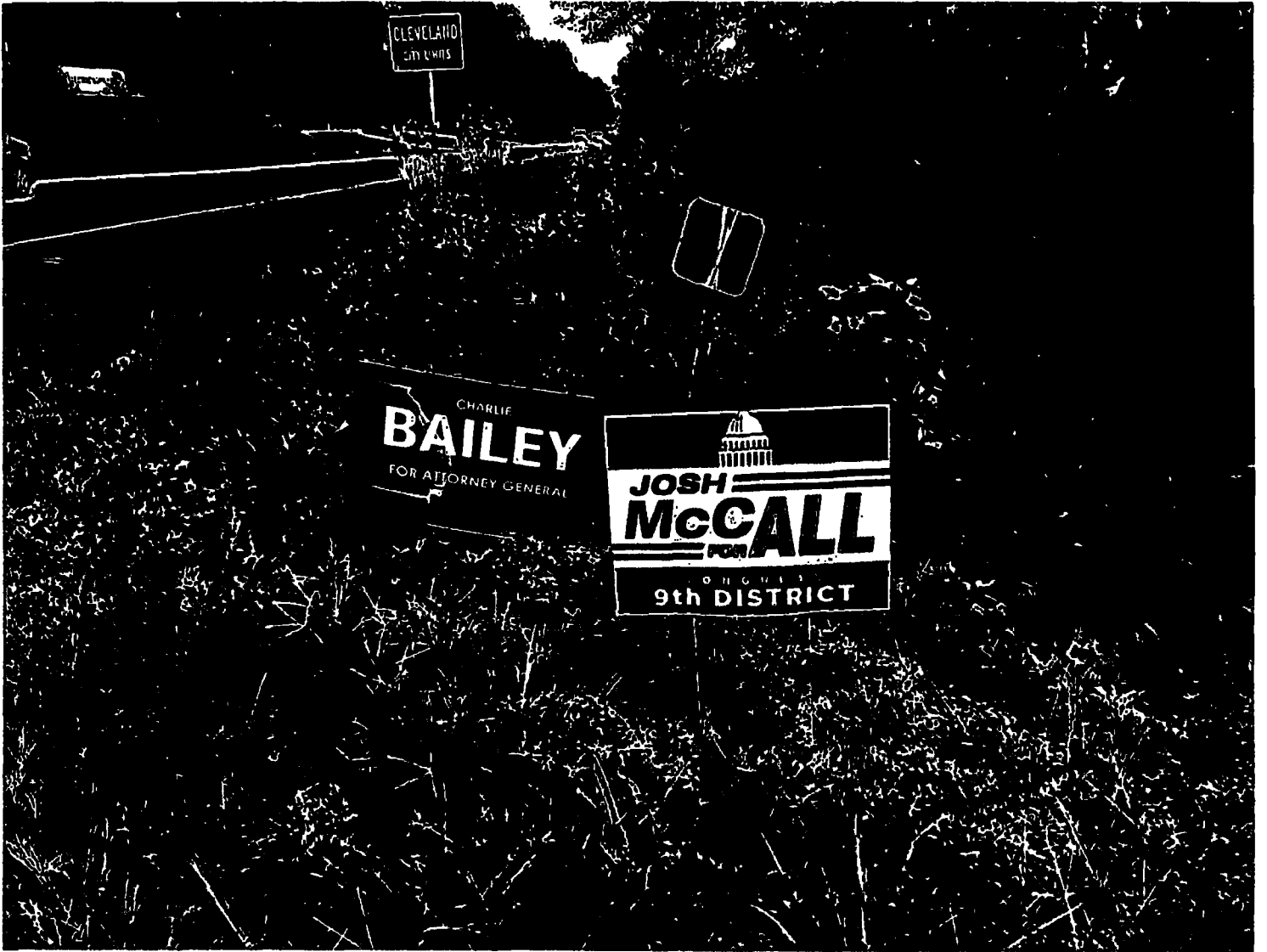
