2. Failed by a vote of 3-2 to:

- a. Dismiss the allegation that Maxine Waters and Citizens for Waters and David Gould in his official capacity as treasurer violated 52 U.S.C. § 30116(f).
- b. Dismiss the allegation that Families & Teachers for Antonio Villaraigosa for Governor 2018 violated 52 U.S.C. § 30116(a)(1)(A).
- c. Approve the Factual and Legal Analysis, as recommended in the First General Counsel's Report dated August 6, 2019, subject to the edits circulated by Commissioner Cooksey's Office on November 8, 2021 at 12:30 p.m.
- d. Approve the appropriate letters.
- e. Close the file.

Commissioners Cooksey, Dickerson, and Trainor voted affirmatively for the motion.

Commissioners Broussard and Weintraub dissented. Commissioner Walther abstained.

3. Decided by a vote of 5-1 to:
