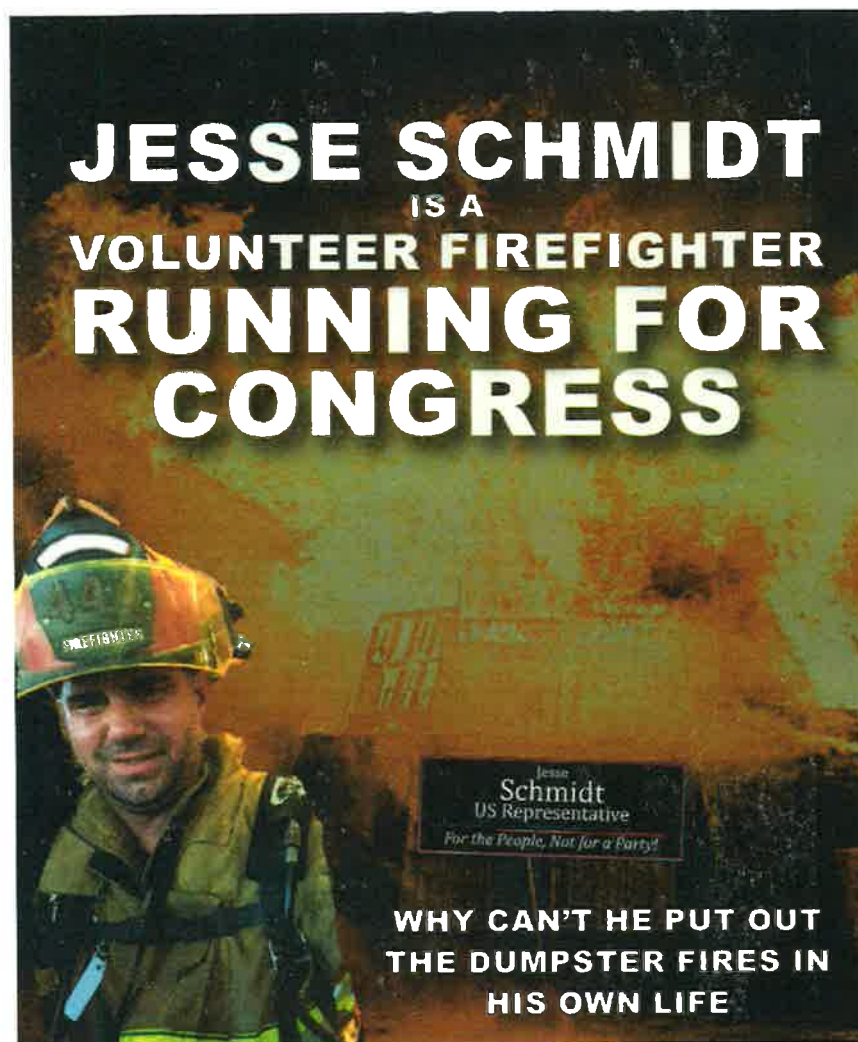

5. Wherefore, the Commission should find reason to believe Jefferson United has violated 52 U.S.C. § 30120(a)(3) and conduct an immediate investigation under 52 U.S.C. § 30109(a)(2).
6. Further, the Commission should seek appropriate sanctions for any and all violations, including civil penalties sufficient to deter future violations and an injunction prohibiting the respondents from any and all violations in the future, and should seek such additional remedies as are necessary and appropriate to ensure compliance with the FECA.
