III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to File 48-Hour Reports)

America Comes First PAC ("the Committee") failed to file two (2) 48-Hour Reports totaling \$68,297.60 to support three (3) independent expenditures disclosed on the Amended 2016 October Quarterly Report, received December 11, 2016, made up to and including the 20th day before the 2016 General Election (Attachment 2).

On December 5, 2016, the Committee filed the 2016 October Quarterly Report, covering the period from July 1, 2016 through September 30, 2016. The report did not include a Schedule E (Itemized Independent Expenditures) (Image 201612059037616713).

On December 11, 2016, the Committee filed an Amended 2016 October Quarterly Report. The Report included a Schedule E disclosing six (6) independent expenditures totaling \$173,297.60 made in support of one (1) federal candidate. The Committee failed to file two (2) 48-Hour Reports to support three (3) independent expenditures totaling \$68,297.60 for the General Election (Images 201612119040604305-7; Attachment 2).

On February 21, 2017, a Request for Additional Information (RFAI) was sent to the Committee referencing the Amended 2016 October Quarterly Report, received December 11, 2016. Among other items, the RFAI noted that the Committee may have failed to file one or more required 48-Hour Reports regarding independent expenditures. A chart was included with the RFAI identifying three (3) independent expenditures, totaling \$68,297.60, for which a 48-Hour Report had not been filed (Images 201702210300081076-80).

On October 10, 2017, the Reports Analysis Division (RAD) Analyst called David Schamens, the Committee's Treasurer, regarding the RFAI referencing the Amended 2016 October Quarterly Report, received December 11, 2016. The Analyst explained that the missing 48-Hour Report for several independent expenditures is an issue that may be referred for further action to another office within the Commission. The Analyst further explained that the purpose of the call was to inform the Committee of the potential referral and give them an opportunity to put further information on the public record if they wished to do so (Attachment 3).

On October 16, 2017, the Analyst left a voicemail message for Mr. Schamens per his request. The Analyst reminded the Committee that any response to the RFAI for the Amended 2016 October Quarterly Report, received December 11, 2016, should be filed by the next business day (Attachment 3).

To date, no further communications have been received from the Committee regarding this matter.
