This letter is on behalf of this firm's client, Center for Voter Information (CVI), in response to the complaint filed in the above-captioned matter by Susan N. Willoughby. A Statement of Designation of Counsel form has been executed (attached).

The Commission should dismiss this complaint outright because there were no factual allegations set forth in the complaint purporting to demonstrate any improper or illegal activities by CVI. CVI is a nonprofit social welfare organization established under section 501(c)(4) of the Internal Revenue Code. More information on CVI can be found at: https://www.centerforvoterinformation.org/. Ms. Willoughby's complaint is premised on the mistaken assumption that a nonprofit organization cannot endorse a candidate. The mailing that is the subject of the complaint is a nonpartisan voter guide; however, even if it were interpreted as endorsing a candidate that is an allowable activity for a 501(c)(4) organization such as CVI.
