Dear Mr. Jordan:

We submit this response on behalf of Congressional Leadership Fund and Caleb Crosby, in his capacity as Treasurer (collectively, "CLF"), in the above-referenced MUR.

This matter must be dismissed immediately as to CLF. The Complaint never alleges that CLF violated the Federal Election Campaign Act (the "Act") or FEC regulations – nor does it even name CLF as a respondent. It claims only that the 3M Company may have violated the Act's prohibition on contributions by federal government contractors when it contributed to CLF on November 1, 2018, as disclosed on CLF's 2018 Post-General Report. There is no allegation that CLF knew 3M to be a federal government contractor, and in fact, CLF had no such knowledge until *after* it received the Complaint in this MUR¹ – at which time CLF promptly investigated the contribution and immediately refunded it upon learning that 3M holds federal contracts.²

It is well established that the Act and FEC regulations prohibit committees' *knowing* solicitation of federal contractor contributions.³ In the past, the Commission has routinely dismissed actions against unknowing recipients of such contributions.⁴ Consistent with that precedent, the Commission must do so here with respect to CLF.
