I hope this e-mail finds you well. I am writing to follow up on our telephone conversation today regarding the correspondence sent by your office to Kemp for Governor, Inc. (KFG) and its Treasurer regarding MUR #7583. Thank you for your time during our discussion today.

KFG and its Treasurer have retained Dentons US LLP to represent it in regard to this matter, and have designated this fact via the attached Designation of Counsel Statements. Please confirm receipt of these documents at your earliest convenience. If you require the original signed versions of these materials, please let us know and we will be sure they are provided in due course.

In conjunction with submission of the attached Designation of Counsel forms, I would also like to request a reasonable extension of time for KFG and its Treasurer to respond to the allegations referenced in the complaint materials forwarded by your office. As I discussed with you by phone this afternoon, KFG and its Treasurer did not receive a copy of the complaint materials in the mail until this past Monday, April 8th. Given that receipt date, we have until Tuesday, April 23rd to respond in a timely fashion, and would ask for an additional 30-day extension to ensure that there is adequate time to address the issues raised in the materials.
