


Dear Mr. Jordan:

I write as counsel to Lori Trahan for Congress Committee (the "Committee"), and Martha Howe, Treasurer of the Committee, (collectively, "Respondents"), regarding the complaint in the above-referenced matter.

The complaint was received on March 25, 2019. Respondents respectfully request that the time for their response be extended until May 9, 2019. Respondents require more time to review the complaint and develop the information necessary for a response. The complaint makes a wide range of disparate allegations and raises a legal question that has been the subject of multiple FEC enforcement actions and audits, and we need additional time to review and incorporate these precedents in our response. Moreover, given the proximity to the FEC reporting deadline and upcoming religious holidays, this will be a busy time for us. Accordingly, we believe this request to be reasonable.
