Dear Federal Election Commission:

The Federal Election Commission (FEC) Laws are about "sunshine" on political activities. In today's environment, the laws when followed, yield transparency into the activity of the candidate and his campaign. The laws are not complex to understand, and should be interrupted literally. When an extremely well-educated candidate and treasurer deliberately evade the laws, the people are cheated and the system fails.

Mr. Matt Strabone ("Strabone") was a candidate for San Diego County Assessor / Recorder / County Clerk in 2018 (Matt Strabone for Assessor/Recorder/ County Clerk 2018¹) and is the principal at Strabone Law, a firm specializing in campaign finance for offices "at the local, state, and federal levels²." Strabone's campaign disclosure statement's identify Ms. Stephanie Sanchez ("Treasurer") as the 2017 - 2018 campaign treasurer on all campaign disclosure forms.

The issue here is Mr. Strabone and his campaign violated FEC registration and reporting rules in 2016 and 2017. You will see in this filing that Mr. Strabone, was a candidate for County of San Diego office, violated the FEC rules requiring candidates to register a campaign and report campaign funds. You will see Strabone transferred contributions raised for an unreported federal campaign. He transferred monies he raised in 2016 and 2017 from an unreported federal election, which Strabone reported to the State of California as a "Federal Exploratory Committee." By raising over \$20,000 and not reporting the Federal campaign Strabone violated FEC rules, and benefited his 2018 campaign for a County of San Diego office with this "dark" money in the State of California.

Issue 1: Strabone had an illegal campaign account reported to the State of California as a Federal Exploratory Committee that received 48 contributions and \$20,300.

The FEC in their "Testing the waters for possible candidacy (2017)" article states An individual who spends money merely to test the waters (but not to campaign for office) does not have to register as a candidate. Nevertheless, funds raised to test the waters are subject to *Federal Election campaign Act's* (the Act) limits and prohibitions." The Act defines that one becomes a candidate that must register and report in accordance with FEC rules when "he or she (or a person working on his or her behalf) receives contributions or makes expenditures that exceed \$5,000." "If the committee's activities go beyond testing the waters and an individual becomes a candidate under the Act, the committee must register and begin filing reports. The funds raised during testing the waters will become contributions, and funds spent will become expenditures. These contributions and expenditures count toward the \$5,000 threshold that the Act uses to determine the candidate is not longer testing the water and requires a committee be formed with all activity reported that initiates candidate status."

Strabone and Treasurer failed to report / file for an FEC candidate-controlled committee after receiving more than \$5,000 for political purposes. They failed to file an Organizational form, failed to report the semi-annual activity of the committee, failed to establish a committee bank account, failed to report the contribution and expenses of the committee.

On Strabone's California Fair Political Practices Commission ("FFPC") form 460 filed in July of 2017 he reports a campaign funds transfer on April 18, 2017 from "Matthew Strabone Federal Exploratory Committee" to his "Matt Strabone for Assessor/Recorder/ County Clerk 2018" campaign.

There are no FEC filings or FFPC filings with any disclosure covering the period from July 1, 2016 - December 31, 2016. During this period the campaign received over twenty contributions totaling \$8,950.

Strabone and Treasurer on their California FFPC form 460 (Recipient Committee Campaign Statement) filed 7/31/2017 covering period 1/1/2017 – 6/30/2017 reported twenty contributions received prior to 12/31/2016 totaling \$8,950.

Forty-eight contributions totaling \$20,300 were received by Strabone and Treasurer prior to their 4/4/2017 filing of form 410 Statement of Organization Recipient Committee forming "Matt Strabone for Assessor/Recorder/County Clerk 2018" committee.

Strabone and Treasurer on their California FFPC form 460 reported they received seven contributions between December 9 – December 22, 2016 totaling more than \$5,000. See the contributions listed below.

1. 12/09/2016 – Genevieve Norwood – \$1,350
2. 12/09/2016 – Jonathan Norwood - \$1,350
3. 12/14/2016 – Keanan Lane - \$300
4. 12/15/2016 – Meika Strabone - \$500

- 6. 12/18/2016 – Danielle Pappas - \$1,000
- 7. 12/22/2016 – Dave Stewart - \$100

Total: \$5,100

Contributions count toward the threshold that determines whether an individual has qualified as a candidate under the Federal Election Campaign Act (the Act). 100.3(a).

By receiving over \$5,000 in contributions on December 22, 2016, an amount greater than \$5,000 for political purposes, he was required under the Act requirement to file and form an official candidate committee. The committee was required to file campaign statements by specified deadlines disclosing contributions received. Strabone and Treasurer failed to file required committee formation papers and statements in accordance with the Act. Strabone and Treasurer intentionally ignored FEC basic disclosure rules by failing to disclose over \$20,000 and forty-eight contributions received from 12/1/2016 – 4/5/2017 – a period of nearly five months.

Please note: \$2,700 under the Act is the campaign contribution limit for individuals per election to a candidate's campaign. 110.1(a) and (b)(1). The contribution is \$800 per cycle for the San Diego County Assessor / Recorder / County Clerk. Above, as reflected in the contributions received by Strabone on 12/09/2016 – Genevieve Norwood and Jonathan Norwood total to \$2,700. This amount matches his intent to receive the unique federal limit of \$2,700. In addition, on 12/18/2016 Strabone received a contribution from Danielle Pappas of \$1,000. Again, this exceeds the \$800 County limit and reflects his intent to raise funds for a Federal effort.

The only reported portion of these contributions were the amount to the State of California, but Federal Exploratory Committees are required to keep documentation of who these checks were made to and for which effort. They will reflect the intent of the Candidate and Treasurer.

No In-kind or expenses reported:

Lastly, no campaign expenses or in-kind contributions made were reported either and the violation can be greater than what was reported on the State of California documents. Due to not filing the violation can be greater than discussed above.

Violation #2: Never Filed FEC Form 2 State of Candidacy or Organization

Candidates / Organizations exceeding the \$5,000 threshold as discussed above are required to form a candidate committee by filing FEC Form 2. Mr. Strabone and Treasurer have never filed the required form.

Violation # 3 - Never filed FEC committee reports from 12/31/2016, 6/30/2017, and closing account reporting periods.

There are no FEC filings or FFPC filings with any disclosure covering the period from July 1, 2016 - December 31, 2016. During this period the campaign received over twenty contributions totaling \$8,950.

Strabone and Treasurer failed to disclose over \$20,000 and forty-eight contributions received from 12/1/2016 – 4/5/2017 – a period of nearly five months.

Strabone on FFPC report of 6/30/2017 acknowledged the transfer of the federal funds, but never filed a report closing a Federal Election account.

Violation #4 – Never established an FEC campaign bank after receiving more than \$5,000 and 48 campaign contributions totaling over \$20,000

FEC requires a campaign account must be established to keep campaign funds separate from individual's personal funds. 102.10, 102.15, 103.2 and 103.3(a).

Strabone and Treasurer only disclosed a bank account subsequent to forming their County Campaign and shows no separate account for the funds after they received \$5,000 in contribution on December 22, 2016.

Strabone and Treasurer violated the Act by receiving over \$5,000 in campaign contributions in December 2016 and not opening a committee bank account. By not filing any campaign finance report. All to hide funds to be used in a local election. This was a shell game of dark money.

Strabone reported only opening a Mission Federal Credit Union bank account for the Committee on March 31, 2017 as reported on the April 5, 2017 FFPC form 410 "Statement of Organization Recipient Committee. Of the forty-eight contributions, Strabone reported receiving seven contributions by 12/22/2016 totaling \$5,100. Once Strabone received the \$5,100, an amount greater than \$5,000 for political purposes Strabone was legally required to open one bank account, report that account, and have all campaign expenditures come from that account.

Strabone received Over \$20,000 was received by that date and transferred from a non-existing / unreported bank account that supported Strabone's unreported campaign activities from 48 contributions the campaign had received prior to that report.

Violation #5 – Candidate deposited campaign funds in a non designated campaign account

Strabone and Treasurer violated the Act by receiving over \$5,000 in campaign contributions in December 2016 and not opening a committee bank account and depositing reported contributions in a personal account.

Strabone and Treasurer violated the Act by receiving over \$5,000 in campaign contributions in December 2016 and not opening a committee bank account.

Strabone reported only opening a Mission Federal Credit Union bank account for the Committee on March 31, 2017 as reported on the April 5, 2017 FPPC form 410 "Statement of Organization Recipient Committee. Of the forty-eight contributions, Strabone reported receiving seven contributions by 12/22/2016 totaling \$5,100. Once Strabone received the \$5,100, an amount greater than \$5,000 for political purposes Strabone was legally required to open one bank account, report that account, and have all campaign expenditures come from that account.

Strabone received Over \$20,000 was received by that date and transferred from a non-existing / unreported bank account that supported Strabone's unreported campaign activities from 48 contributions the campaign had received prior to that report.

Campaign Violation #6 – Candidate has not disclosed personal funds used for campaign expenditures prior to establishing a campaign account and after required to do so by the Act.

Violation #7: Treasurer Violated FEC Treasurer Duties

Treasurer's Duties (or designated assistant treasurer) is responsible for: Filing complete and accurate reports and statements on time. 104.14(d). Signing all reports and statements. 102.2(a) and 104.14(a). Depositing receipts in the committee's designated bank within 10 days of receipt. 103.3(a). Authorizing expenditures or appointing an agent (either orally or in writing) to authorize expenditures. 102.7(c). Monitoring contributions to ensure compliance with the law's limits and prohibitions. 103.3(b). Keeping the required records of receipts and disbursements for three years from the filing date of the report to which they relate. 102.9(c) and 104.14(b).

A committee's treasurer is personally responsible for carrying out the duties listed above and should understand these responsibilities (as well as his or her personal liability for fulfilling them) before taking them on.

Since 12/22/2016, when Treasurer received over \$5,000 triggering the FEC candidate requirements they have filed no FEC forms, signed no statements, not deposited contributions received in a committee designated bank account, authorized illegal expenditures, allowed non-compliance with the FEC rules, and has been an accomplice in the Candidate's violation of the Act.

The Treasurer is liable for their failure to do their job and the candidate's violations in accordance with the Act.

Unanswered Questions Due to unfiled reports and no campaign bank accounts

Due to lack of transparency and violations of FEC reporting rules there is a lack of information that has generated unanswered questions.

1. Who did Strabone have 2016 and January – April 2017 campaign contributions made out too? Was it Strabone for Congress? Was it Strabone for Assessor?
2. Strabone expensed "Chevron" gasoline on his reports. Did he pay for expenses while campaigning from December 2016 – April 2017? Are there unreported expenses?

All of the activities and facts discussed herein are supported by the sworn statements by Strabone and Treasure on FPPC filings. Copies that were filed with the FPPC are on record with the County of San Diego. Copies have been included for your convenience.

These facts are all in the records and FPPC forms. The FEC laws are there to promote "sunshine" in character and are signed under oath by both Strabone and Treasurer. Both Strabone and Treasurer are campaign finance professionals and both promote themselves as campaign finance experts in their respective fields of finance and law. Both Strabone and Treasurer created a "shell game" and are liable for the violations as laid out.

Thank you for your consideration and concern with upholding the Act.

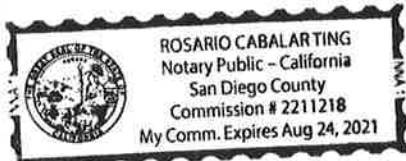
