To whom it may concern,

I am writing to file an official complaint against Dianna Ploss and "MA4Trump", who claim to be helping a Federal candidate and are raising money for that purpose.

I am enclosing a copy of an advertisement from the January 2019 edition of the Boston Broadside, a monthly newspaper published out of Peabody Massachusetts. The advertisement specifically includes a solicitation of funds, "payable to MA4Trump" which would indicate that they have an account, which according to your web site, is not registered with the FEC.

In addition to the *prima facia* evidence of activity in violation of Federal Election Law, "MA4Trump" is claiming to be a candidate committee, although they have no affiliation with any registered candidate committee or PAC. "MA4Trump" is also using the name of a candidate, Donald J. Trump, in violation of FEC rules.

Furthermore, even if "MA4Trump" was an FEC registered committee, the advertisement lacks the appropriate "paid for" disclaimer as per FEC rules.
