Complaint Against Paul Manaport, 2016 Campaign Manager for Donald J. Trump.

Pursuant to Code 52 sec 30109 & Code 11 C.F.R. sec 111.4,,

I, Angela Marie Walls-Windhauser,
an African-American Female Candidate for the United States of America Senate hereby
have written and will swear by notary this complaint.

In 2016 a Representative of the Campaign for Donald Trump to become U.S. President
utilized Foreign Funds Provided by Paul Manaport combined with other funding to
unfairly block
a U.S. Federal Candidate's Television Ad, Angela Marie Walls-Windhauser Campaign for
United States Senate,
whereby,
Violating code 52 section 30109 and code 11; expressing that Foreign funds used
in U.S. elections is not a victimless crime.

On Friday November 4, 2016 at approximately 8:30pm Channel 13 was
set to air Angela Marie Walls-Windhauser's 30-second U.S. Senator Campaign Ad for
the last Friday before the 2016 Election.

The Ad was paid for scheduled and millions of voters were watching.

However, while my family and I were watching that channel waiting, my cell phone
rang.

It was Scott at BrightHouse Ad Sales calling; "Angie, I'm sorry, it's not going to
run,
one of Trump's guys just came into the Studio and plopped down about a Million bucks
to take your spot! I'm so sorry."

So, my last Ad to run for my Campaign for the United States Senate was not just
bumped
it was canceled and replaced with an Ad about Donald Trump for President.

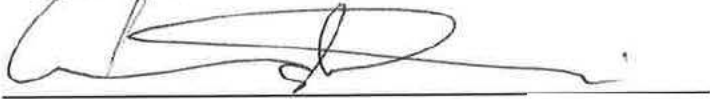
We were devastated and there were no refunds, and millions of Florida voters were
